PROCEEDINGS of the Regular Board Meeting of the **California Horse Racing Board** held at the **Del Mar Satellite Wagering Facility**, 2260 Jimmy Durante Boulevard, Del Mar, California, on **July 25, 2002**.

MINUTES

Chairman Landsburg asked for approval of the minutes of the Regular Board Meeting of June 6, 2002. Commissioner Granzella **motioned** to approve the minutes. Vice-Chairman Licht **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE BAY MEADOWS OPERATING COMPANY, LLC (T) AT BAY MEADOWS, COMMENCING AUGUST 30 THROUGH NOVEMBER 3, 2002, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Bay Meadows Operating Company (BMOC) proposed to run 49 days, two days less than in 2001, for a total of 421 races. Ms. Wagner stated BMOC had a number of first post times that would correlate with the overlaps, and listed them in date order. She noted the horsemen's agreement had been received and the fire clearance was missing from the application. Ms. Wagner stated staff recommended approval of the application conditioned upon receipt of any items the analysis noted as missing. Bernie Thurman of BMOC said her organization felt running a twilight card concurrent with Del

Mar would increase handle. Running concurrent with Del Mar would be beneficial to all parties as BMOC was a partner with Cal Expo on the off-track commissions. The three tracks would be running at the same time, and would coordinate post times just as they would during other days of the week. Ms. Thurman said BMOC offered to make Cal Expo whole regarding any out-of-state or on-track commissions lost due to BMOC changing its post time. She stated BMOC thought it would be beneficial to run Wednesday, September 4, concurrent with Del Mar. A letter requesting the date had been submitted to the Board; however, the amendment was not granted as an allocated race day. Commissioner Harris commented the Race Dates Committee attempted to move away from six-day weeks in Northern California to try boost the size of the fields. He stated he did not think it would be prudent to add another day when BMOC's fields were still only seven head per race. Ms. Thurman stated BMOC believed September 4 was a unique day. New York would be dark so California export handles would probably be higher than normal. Experience demonstrated handles increased on days when two or more California cards were offered concurrently. Ms. Thurman said BMOC felt it would be beneficial for the entire state, increase jobs, and increase opportunities for horsemen to earn purses. Otherwise, Ms. Thurman said, September 4 would be the only day Southern California would be running without a Northern California signal. Vice-Chairman Licht asked if it was true Arizona's Turf Paradise earned a million dollars in handle on Tuesdays because they were the only course for New York fans to wager on. Ms. Thurman said that was correct. She stated it was a "shelf-space" issue. Fans who wished to wager on an out-of-state location had no New York races to wager on, so they wagered on other locations. Craig Fravel of Del Mar Thoroughbred Club (DMTC) said his organization had a lot of experience with concurrent cards, and strongly supported BMOC's request to run on September 4. He

stated there was a significant impact on Southern and Central zone handles when there was no concurrent Northern signal. Mr. Fravel said he was glad to hear other California tracks would be running concurrently with DMTC on Fridays. Don Johnson of Thoroughbred Owners of California (TOC) said his organization supported BMOC's request to run on September 4. Dave Elliott of Cal Expo said he would like to know if the increased overnight purses proposed by TOC in its agreement with BMOC would occur during the overlap. By law, Cal Expo would be required to pay 100 percent of what BMOC paid, and would have to write an addendum to its condition book. Mr. Elliot asked if BMOC was planning to run concurrent with Fairplex Pomona during the day on Fridays. Ms. Thurman said the first Friday BMOC would run concurrently with Fairplex Pomona during the day. The second and third Fridays, BMOC would run in the evening. Mr. Elliott stated Cal Expo received a letter from BMOC which discussed how it would make Cal Expo whole. In the letter BMOC proposed Cal Expo make up any purse money it lost from the supplemental purse fund. Mr. Elliott said that was not possible. Cal Expo was allocated a specific amount from the supplemental purse fund because of the overlap, and no more. He stated any purse deficiencies due to BMOC's overlap would have to be made up by Cal Expo, not BMOC. Mr. Elliot stated by racing on Friday night BMOC would make a few extra thousand dollars at Cal Expo's expense. He said he would like the Board to have BMOC run the Friday night at 7:15 p.m. rather than at 3:15 p.m. with Cal Expo. Peter Tunney of Magna Entertainment Corporation said there had been hours of testimony regarding concurrent running of meetings, and there was no question that if a meeting was being held in Southern California the dates should be covered in Northern California. Mr. Tunney said concurrent running was in the best interest of the state and the industry. Charles Dougherty of California Thoroughbred Trainers (CTT) said his organization

shared Commissioner Harris's concerns regarding running a six-day week in Northern California. However, as BMOC was asking for only one day, and would not ask for additional six-day weeks, CTT supported the request. Commissioner Harris asked if BMOC would be open to receiving a simulcast signal on September 4. Ms. Thurman said it was a possibility BMOC was leaving open. Commissioner Harris asked if there was any other date in BMOC's fall schedule that would be a viable substitute for September 4. Ms. Thurman said September 4 was the only non-concurrent race date in the schedule. She stated if BMOC picked up another date it would result in a four-day race week, which was something she did not care to do given BMOC's labor situation. Ms. Thurman added that in September 2001 field sizes were larger than those during the rest of the year. She stated with cooperation from the horsemen and much effort by the racing office and the year-round purse program, field sizes during BMOC's spring meeting actually increased. Commissioner Bianco **motioned** to approve the request by BMOC to add September 4, 2002, to its race dates. Vice-Chairman Licht **seconded** the motion, which was **carried** with Chairman Landsburg, Vice-Chairman Licht, Commissioner Bianco and Commissioner Granzella voting "yes" and Commissioners Harris and Sperry voting "no." Chairman Landsburg asked if the Friday night represented a change over the 2001 BMOC schedule. Ms. Thurman said in 2001 BMOC raced all its Fridays at night. In 2002 BMOC proposed to run two Friday twilight cards and a Friday day card. The balance of seven Fridays would be run at night with no concurrent racing in Southern California. Commissioner Harris said he had no problem with BMOC running on Fridays. He stated his only concern was that Cal Expo be made whole if it was damaged. Ms. Thurman said the off-track handle was split 60/40, with Cal Expo receiving the larger share. Each party would keep their respective on-track handle. She stated BMOC believed the Friday night

would actually generate more revenues for Cal Expo. Mr. Elliott said when BMOC directly overlapped his organization Cal Expo was the third man out in California. He stated if out-of-state wagering was considered, live on-track commissions for Cal Expo also would be diminished. Mr. Elliott said BMOC was offering to make up Cal Expo's losses in live on-track handle, but there were caveats with the offer as it was based on comparable race cards. He asked who would determine what was comparable? Additionally, if Cal Expo's satellite wagering commission made up the difference in live commissions, BMOC would not make Cal Expo whole. Mr. Elliott said Cal Expo was willing to negotiate, but it wanted to be made whole for the one day. Ms. Thurman said the spirit of BMOC's offer was if in total Cal Expo was harmed, it would be made whole. She stated BMOC felt the 60 percent commission increase would more than compensate any loss in off-track and on-track handle. Vice-Chairman Licht **motioned** to approve the Friday racing schedule as proposed in BMOC's license application. Commissioner Bianco **seconded** the motion, which was **carried** with Vice-Chairman Licht and Commissioners Bianco, Granzella, Harris and Sperry voting "yes," and Chairman Landsburg **abstaining**. Commissioner Sperry **motioned** to approve the application for license to conduct a race meeting of BMOC. Commissioner Granzella **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE LOS ANGELES COUNTY FAIR (F) AT FAIRPLEX, COMMENCING SEPTEMBER 13 THROUGH SEPTEMBER 29, 2002, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Los Angeles County Fair (LACF) proposed to run 17 days, the same number of days as 2001, for 204 races, eight more than in 2001. The first post

time would be 12:30 p.m. daily and wagering would be offered under CHRB rules. Ms. Wagner stated the horsemen's agreement had been received, and staff recommended approval of the application conditioned upon receipt of any items the analysis noted as missing. Chairman Landsburg said he noted the Thoroughbred Owners of California (TOC) letter had a caveat regarding Advance Deposit Wagering, that indicated prior to the LACF meeting TVG would attempt to eliminate the Oregon fee as a deduction from the market fee. Wilson Shirley of TOC said his organization had been advised the .25 percent Oregon hub fee was waived on wagers made by California residents. He stated the .25 percent would revert to a market access fee for California hosts. The fee reduction would commence the first day of the Del Mar meeting. Commissioner Sperry **motioned** to approve the application for license to conduct a horse racing meeting of LACF. Commissioner Bianco **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF CAPITOL RACING LLC, (H) AT SACRAMENTO, COMMENCING SEPTEMBER 27, 2002 THROUGH FEBRUARY 23, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said Capitol Racing (CR), LLC proposed to run 87 nights for a total of 1,110 races. Ms. Wagner stated there would be racing three nights per week through October 12; four nights per week through December 21; and five nights per week through February 23, 2003. There would be 12 simulcast races on nights without quarter horse overlap and six simulcast races during overlap. Ms. Wagner stated the fire clearance was missing from the application. She said staff recommended approval of the application conditioned upon receipt of any items the analysis noted as missing. Commissioner Granzella

motioned to approve the application for license to conduct a horse racing meeting of CR, LLC. Commissioner Bianco **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPROVAL OF THE ANNUAL DISTRIBUTION OF A PORTION OF THE UNCLAIMED REFUND MONIES, ADJUSTED FOR INFLATION, TO THE JOCKEYS' GUILD HEALTH AND WELFARE TRUST, PURSUANT TO BUSINESS AND PROFESSIONS CODE SECTION 19612.9.

John Reagan, CHRB staff, said the CalPERS benchmark was used for past increases in the annual distribution of unclaimed refund monies to the Jockeys' Guild (Guild) Health and Welfare Trust. Mr. Reagan said the CalPERS increase for 2002 was 25.1 percent. He stated the Guild asked for a 30 percent increase in the distribution. With a 30 percent increase, the distribution would amount to \$884,235, while a 25.1 percent increase would equal \$850,000. Commissioner Harris asked where unclaimed refund monies went if they were not distributed to the Guild. Mr. Reagan said they were held by the associations for three years, then returned to the state as unclaimed personal property. The money represented tickets removed from the pool due to a scratch or other situation. Mr. Reagan stated unclaimed refund monies amounted to over a million dollars a year, and were generated among the various tracks. Commissioner Bianco asked if Advance Deposit Wagering (ADW) affected the refund monies. Mr. Reagan said with ADW there were no refunds as funds were immediately credited and debited to accounts. Mr. Reagan stated the Thoroughbred Owners of California (TOC), which was a partner in the distribution and the welfare fund, had indicated it would prefer approval of the 25.1 percent increase. Chris McCarron of the Guild asked that the 30 percent increase be approved. He stated every dollar approved went towards health and welfare benefits with a

small amount used for administrative expenses. Commissioner Harris asked how the Guild established eligibility for the fund. Mr. McCarron said to be eligible a jockey must have ridden 100 mounts in the calendar year, half of which had to be in California. Chairman Landsburg asked if the Guild policed claims to verify their legitimacy. Mr. McCarron said doctor's bills were processed by the Guild in the same manner an insurance company would administer them. Chairman Landsburg said he believed it was important to remember there was a 15 to 20 percent lag in workmen's compensation payments due to fraud. He stated he thought the Guild should reexamine its payments at random to make sure its system was effective. Chairman Landsburg said the Board was authorizing a transfer of funds to the Guild and he thought it was incumbent on it to be able to certify its claims were legitimate. Vice-Chairman Licht **motioned** to approve the request of the Guild to increase the allocation of unclaimed refund monies to 30 percent. Commissioner Bianco **seconded** the motion, which was **unanimously carried**. Commissioner Granzella **motioned** to approve the annual distribution of a portion of the unclaimed refund monies, adjusted for inflation, to the Guild's Health and Welfare Trust. Commissioner Harris **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE OAK TREE CHARITABLE FOUNDATION TO DISTRIBUTE CHARITY RACING DAY PROCEEDS IN THE AMOUNT OF \$97,000 TO 47 BENEFICIARIES.

John Reagan, CHRB staff, said the request by the Oak Tree Charitable Foundation (OTCF) would distribute 53 percent of the charity racing day proceeds to racing-related charities. He stated staff recommended approval of the request. Commissioner Sperry **motioned** to approve

the request of the OTCF to distribute charity racing day proceeds in the amount of \$97,000 to 47 beneficiaries. Commissioner Bianco **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE PACIFIC RACING ASSOCIATION TO DISTRIBUTE CHARITY RACING DAY PROCEEDS IN THE AMOUNT OF \$68,300 TO 17 BENEFICIARIES.

John Reagan, CHRB staff, said the request by the Pacific Racing Association (PRA) would distribute 68 percent of the charity racing day proceeds to racing-related charities. He stated staff recommended approval of the request. Commissioner Granzella **motioned** to approve the request of the PRA to distribute charity racing day proceeds in the amount of \$68,300 to 17 beneficiaries. Commissioner Sperry **seconded** the motion, which was **unanimously carried**.

STAFF REPORT ON THE FOLLOWING CONCLUDED RACE MEETINGS:

John Reagan, CHRB staff, said the Los Angeles Turf Club had an excellent meeting. He commented staff determined Advance Deposit Wagering (ADW) did not have an impact on the over-all handle. Mr. Reagan stated San Joaquin Fair (SJF), the first fair of the season, was down a few percent on total handle, but he did not know if ADW was the cause. Mr. Reagan said staff was monitoring the other fairs in Northern California and noted they too were down several percent in various areas. He did not believe ADW had a direct impact, but it could have had some effect. Mr. Reagan stated ADW and the economy, as well as a heat wave in

Northern California, could have combined to cause a down-turn in the fairs. Vice-Chairman Licht said he thought it would be beneficial if the industry were to initiate an objective statistical review of the effect of ADW. He stated a suggestion had been made to fund a statistical study by the University of Arizona. Chairman Landsburg commented while the industry was maintaining its dollar averages a 5.48 percent drop in daily attendance indicated it was losing its live audience. Mike Ziegler of Santa Anita Park Race Track (Santa Anita) said he could account for his organization's drop in attendance. Mr. Ziegler said Santa Anita changed its policy regarding the importation of food onto its facility. He stated persons known as "pot-luckers" had been allowed to bring food onto the facility. Such persons generally did not wager or buy food. After the policy was changed the on-track attendance dropped by 5.48 percent but the handle was not affected. Chris Korby of the California Authority of Racing Fairs said the first week of the SJF was overlapped by the Bay Meadows meeting. He stated there was difficulty filling races the second Friday and Saturday, which was a contributing factor to the decline.

STAFF UPDATE ON THE ADVANCE DEPOSIT WAGERING HANDLE.

John Reagan, CHRB staff, said through July 6, 2002, 66.3 million dollars had been handled in California through the Advance Deposit Wagering (ADW) system. Mr. Reagan stated the ADW handle represented an increase from 5.3 percent to 5.7 of the total California handle. Mr. Reagan said staff was working with the hubs and CHRIMS regarding maintenance and auditing of the database to ensure the data was valid. Within a short time the ADW handle

would be processed much like the regular handle with data reports available and the distribution made weekly.

REPORT ON THE IMPLEMENTATION OF ADVANCE DEPOSIT WAGERING.

Ed Hannah of XpressBet said his organization would support an effort to determine the effect of Advance Deposit Wagering (ADW) on California's handle. He stated XpressBet believed hiring a statistician through the racing program at the University of Arizona would be a good start, and his organization was prepared to fund a portion of the cost. Mr. Hannah said California residents made 90 percent of the wagers received by XpressBet's California hub. The total number of wagers received by the California hub was 11,058 out of just over 11,000 accounts. The total dollars wagered on XpressBet's California hub since its inception in January 2002 was just over \$24 million. Seventy four percent of XpressBet's accounts were opened through its call center; 16 percent were opened at XpressBet's centers at Santa Anita; and 5 percent were opened at Golden Gate Fields and at Bay Meadows. Mr. Hannah stated 47 percent of XpressBet's handle was wagered on races at Santa Anita; nine percent on Bay Meadows races; eight percent on Golden Gate Fields races; and 36 percent was wagered on races at other venues. Ron Luniewski of XpressBet said his organization would soon introduce a new, more user friendly web site. In addition, XpressBet had changed its funding vendor, so there would soon be a substantial upgrade in the timeliness of financial transactions. Mr. Hannah said XpressBet launched its Horse Racing TV (HRTV) channel from its production center at Santa Anita. However, the channel was limited to distribution through a private

satellite service, so it did not have broad distribution. He noted comments received regarding the broadcasts were positive. Mr. Hannah explained the content of HRTV channel broadcasts and stated XpressBet was in discussions with national cable and satellite carriers, as well as California broadcast companies for broader distribution. Commissioner Harris asked if it would be possible to show HRTV channel content on the Internet. Mr. Hannah said XpressBet was not the sole owner of HTRV. He stated to show the channel on the Internet would require permission of XpressBet's partners. Commissioner Harris asked if any banks had refused to take credit cards on deposit. Mr. Luniewski said there were banks that would attempt to stop an Internet gaming transaction, however, after an education process, they would allow the transactions. Mr. Hannah commented there was federal legislation proposed that would make it illegal for credit cards to be used for illegal gambling purposes. He stated XpressBet was working with the American Horse Council to make sure legal gambling operations such as ADW were not included. Commissioner Harris said he understood XpressBet charged a three percent fee on credit card deposits. He asked if the fee had impacted XpressBet's competitive advantage. Mr. Luniewski said the recent change in its financial vendor resulted in a cheaper fee. He stated XpressBet was considering dropping the fee, which was purely a cost flow-through and did not represent a profit to the organization. Mr. Hannah said the three per cent fee was the result of there being no signed credit card receipt when an advance deposit was made. This resulted in opportunities for fraud and improper credit card advances. XpressBet had a contract with an entity that was prepared to assume the risk. However, to assume the risk, the entity charged XpressBet a three percent fee. Commissioner Harris said XpressBet had a lot of information on its ADW account holders, and the risk of fraud was no different for its competitors. Mr. Luniewski said XpressBet's change in vendors would result in savings

passed on to its account holders. He stated XpressBet was also looking at other ways to conduct transactions. Chairman Landsburg said the interest earned on ADW accounts was to be held for charity. He stated he had not seen a report regarding the issue. Mr. Luniewski said information regarding interest was given to CHRB staff.

Tony Allevato of TVG said his organization's California handle as of July 2002 was 33.8 million dollars. He stated California ADW account holders had wagered 60 percent on in-state races, and 40 percent on out-of state races. Non-California residents had wagered \$4.7 million on California races, which represented 23 percent of the handle TVG received on California tracks. TVG currently had just under 14,000 ADW account holders in California. Mr. Allevato stated the Oregon Racing Commission lifted the .25 percent tax on wagers placed by California residents. The elimination of the tax resulted in a decrease of the hub fee from 6.25 percent to six percent. The residual quarter point would increase the return to California racetracks and horsemen through the market access fee. Mr. Allevato said TVG entered into an agreement with FOXSports.com which would allow video streaming of its races through the Internet site. He stated the FOXSports.com site was the second largest sports web site with four million viewers a month. There was no membership fee for the FOXSport.com service, but one had to be a TVG account holder. Mr. Allevato said the California Racing Fairs had entered into an agreement with TVG and wagering on their races became available in late June 2002. Mr. Allevato talked about racing coverage provided by its Fox television channel shows. He explained the ratings various shows received, and related how TVG covered the American Oaks event at Hollywood Park. Mr. Allevato concluded by talking about future television coverage on Fox television channel. Vice-Chairman Licht said he understood TVG

was video streaming its product on the Internet. He stated he thought that was a violation of some of TVG's contracts. Mr. Allevato said TVG could not video stream its entire program, but could offer specific races and post parades. He stated the video streaming did not include TVG announcers doing commentary. Commissioner Harris asked if TVG had any banks that would not take credit card transactions. Mr. Allevato said TVG had not experienced any problems with banks. Commissioner Harris asked if TVG saw any trends regarding its account holders. Mr. Allevato said of the account holders who made regular wagers, the per capita was about \$140 per day, but he did not know the number of active accounts.

Joseph Hasson of YouBet.com said since his organization received its license in February 2002 it handled 14.1 million dollars in wagers. Of that figure California residents wagered 5.21 million dollars on California races, and 7.56 million dollars on out-of-state races. Out-of-state residents wagered a significant amount of money on California races. Mr. Hasson said YouBet.com was providing ADW on all California fair meetings, which had been received favorably by the fan base. He stated since it received its license, YouBet's California ADW account holders grew from 5,000 to a total of 9,000 accounts. In addition, YouBet acquired a large number of out-of-state accounts. Vice-Chairman Licht asked why YouBet was not allowed to broadcast over ESPN. Charles Champion of YouBet said his organization entered into an agreement with Winnercomm and National Thoroughbred Racing Association (NTRA) productions, which is a subsidiary of NTRA. He stated YouBet experienced difficulty with NTRA regarding the execution of the contract as NTRA productions did not inform its parent company of its existence. The NTRA contacted its exclusive marketing partner, TVG, and subsequently notified YouBet it could not broadcast. Mr. Champion stated YouBet was

attempting to resolve the issue and believed it was close to bringing its site up with California content. Mr. Champion commented he needed to clarify the issue of credit card fees. He stated YouBet also charged fees and had done so for approximately 30 days. He stated YouBet's fee was 3.98 percent. YouBet had not seen any effect on credit card transactions as a result of the fee. Mr. Champion stated credit cards were an increasing problem for his organization and for ADW in general. CitiBank was denying use of its cards for ADW transactions, and there were states that prohibited funding ADW accounts with credit cards or placed holds on credit card funds. Mr. Champion said YouBet placed a credit card block on the ADW accounts of customers from such states. He stated another issue with credit cards was that companies were taking larger reserves on the accounts. When an account was funded with a credit card the funds were withheld from YouBet. Mr. Champion stated it was a real problem for YouBet as it had approximately \$750,000 being held in reserve by credit cards companies. Commissioner Harris commented credit cards were a concern to the entire industry. He stated he believed the industry needed to work with banks to educate them regarding the differences between legal and illegal wagering. Commissioner Harris said he understood YouBet allowed its account holders to fund their accounts using an electronic check. Mr. Champion said YouBet believed its "express cash" function was the most efficient way its customers could fund their accounts. He stated YouBet did not charge fees for the service.

GENERAL BUSINESS

Michael Braver, a racing fan, spoke about his disagreement with the Stewards' actions regarding the sunset handicap at Hollywood Park on July 21, 2002. Chris McCarron of the Jockeys' Guild (Guild) said his organization wished to express its opposition to the use of shock wave therapy at racetrack setting. He stated the Guild appreciated the Board's policy regarding use of the therapy.

MINUTES

Chairman Landsburg asked for approval of the minutes of the Regular Board Meeting of June 26, 2002. Sherwood Chillingworth of Oak Tree Racing Association presented a correction to the minutes of the Regular Board Meeting of June 26, 2002. Commissioner Moretti **motioned** to approve the minutes as amended. Commissioner Bianco **seconded** the motion, which was **unanimously carried**

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE OAK TREE RACING ASSOCIATION (T) AT SANTA ANITA, COMMENCING OCTOBER 2 THROUGH NOVEMBER 3, 2002, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Oak Tree Racing Association (OTRA) proposed to run 26 days, six days less than in 2001, for a total of 223 races. The first post time would be 1:00 p.m. weekdays and 12:30 p.m. weekends and holidays. Ms. Wagner stated the post time for Breeder's Cup on October 26, 2002, would be 9:30 a.m. The post time for Cal Cup on November 2, 2002, would be 12:00 noon. The wagering program would use CHRB

regulations. The only item missing from the application was the fire application. Ms. Wagner said staff recommended approval of the application dependent on receipt of any items the analysis noted as missing. Commissioner Sperry **motioned** to approve the application for license to conduct a horse racing meeting of OTRA. Vice-Chairman Licht **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE FRESNO COUNTY FAIR (F) AT FRESNO, COMMENCING OCTOBER 2 THROUGH OCTOBER 13, 2002, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Fresno County Fair (FCF) proposed to run ten days, one less than in 2001, for a total of 98 races, four less than in 2001. The first post time would be 12:37 p.m. weekends, 12:45 p.m. Fridays, and 1:37 p.m. Wednesdays and Thursdays. The wagering program would use CHRB regulations. Ms. Wagner said staff recommended approval of the application dependent on receipt of any items the analysis noted as missing. Commissioner Moretti **motioned** to approve the application for license to conduct a horse racing meeting of FCF. Commissioner Harris **seconded** the motion, which was **unanimously carried**.

PUBLIC HEARING ON THE ADOPTION BY THE BOARD OF THE PROPOSED REGULATORY ADDITION OF CHRB RULE 1867 – PROHIBITED VETERINARY PRACTICES, TO ESTABLISH CRITERIA AND LIST THOSE DRUGS, SUBSTANCES OR MEDICATIONS WHOSE USE OR POSSESSION OF CONSTITUTES A PROHIBITED VETERINARY PRACTICE.

Dr. Ron Jensen, CHRB Equine Medical Director, said Rule 1867 was an addition to the rules dealing with prohibited veterinary practices. He stated the first two practices to be prohibited under the rule were the possession or use of erythropoietin or darbepoietin within the confines of a facility under the jurisdiction of the Board. Additionally, the rule would prohibit the use and/or possession of any medication that had not been approved by the United States Food and Drug Administration. The Board approved Rule 1867 at the June 2002 meeting and directed staff to initiate the rulemaking process. Dr. Jensen said no comments had been received. He added that since June 2002, seven racing jurisdictions in the United States adopted the rule or began the rulemaking process for similar prohibited practices rules. Jacqueline Wagner, CHRB staff, said staff recommended adoption of the rule as presented. Vice-Chairman Licht asked if a test for Epogen existed. Dr. Jensen said there was a new screening test, however, it was difficult to confirm. Vice-Chairman Licht asked how the Board would proceed if there was a positive test for the drug. If it was difficult to confirm the presence of the drug with current testing procedures, how would the rule work? Dr. Jensen in the event a licensee was found on the premises of a facility under the jurisdiction of the Board in the possession of erythropoietin, it would be a violation of the rule. He stated it was currently not a violation to be found in possession of the drug. Commissioner Harris said he understood the effect of the drug on horses was different than in humans, and the drug was more prevalent among human athletes. Dr. Jensen said horses had a reserve of red blood cells in their spleens. If a horse

was stimulated in any fashion, it would contract the spleen, which would add up to 25 percent more red blood cells in the animal. In humans that would not happen, so the drug would probably work more effectively in increasing stamina in humans as opposed to horses. Horse already had a reserve of red blood cells. With erythropoietin there was the possibility of increasing red blood cells in a horse to such an extent the heart would actually have difficulty pumping blood. Erythropoietin was a human product so the horse's system would recognize it as a foreign substance and develop antibodies towards it. The erythropoietin produced by injection, in combination with the horse's natural erythropoietin, would eliminate the production of red blood cells to the point the horse would become very anemic and require treatment. Commissioner Bianco **motioned** to adopt Rule 1867, Prohibited Veterinary Practices. Vice-Chairman Licht **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE BAY MEADOWS FOUNDATION TO DISTRIBUTE CHARITY RACING DAY PROCEEDS IN THE AMOUNT OF \$105,000 TO 44 BENEFICIARIES.

John Reagan, CHRB staff, said the request distributed exactly 20 percent of the proceeds to horse racing related charities. He stated staff recommended approval of the request. Chairman Landsburg said that while the law required the foundation to distribute only 20 percent of the proceeds to horse racing related charities, most of the requests for distribution included up to 50 percent towards industry related organizations. He stated in the future he hoped to see more of Bay Meadows Foundation's charity proceeds going to racing related charities. Vice-Chairman Licht said he agreed with Chairman Landsburg. However, he stated he was happy to see the horse racing charities chosen by the foundation were people related

rather than horse related charities. Vice-Chairman Licht commented he thought it was a much better use of the charity funds. Frank De Marco, representing Bay Meadows, said the Bay Meadows Foundation was completely independent of the racing association by order of the Superior Court in San Mateo County. He said the only control exercised by Bay Meadows Operating Company was in designating the recipients of the 20 percent dedicated towards racing related charities. Commissioner Bianco said when he was being confirmed by the legislature none of the persons he spoke to seemed to know about the industry's charitable contributions. He asked if the Bay Meadows public relations department could send such information to Senator Burton's committee. Sherwood Chillingworth of Oak Tree Racing Association said his organization had compiled a list of its charitable donations over the last ten years. He stated he would be happy to forward the information to the appropriate parties. Chairman Landsburg said such information should be given to Mike Martin, CHRB public affairs officer. Commissioner Moretti said she would be happy to work with Mr. Martin to see the information was delivered to legislators who represented the districts where the racing associations were located, and to the rules committee. Mike Martin, CHRB staff, said a future newsletter would focus on the issue of charity, and the information could be incorporated materials given the legislature. Commissioner Moretti said she thought it behooved the industry to let the legislature know about its charitable contributions as it was very aware of how much money was contributed by other gaming organizations in California. Commissioner Moretti **motioned** to approve the request by the Bay Meadows Foundation to distribute \$105,000 to 44 beneficiaries. Commissioner Sperry **seconded** the motion, which was **unanimously carried**.

John Reagan, CHRB staff, said the report included the meeting at Hollywood Park (HP) and three fairs. He stated staff was monitoring the meetings for signs of cannibalization from Advance Deposit Wagering (ADW) and other factors. Mr. Reagan said the meeting at HP was good over-all, but on-track attendance was down four percent. He said in July it was noted the Stockton Fair was down three to five percent in various categories. In comparing the three fairs in the current report, Alameda was down slightly more than Stockton, while Santa Rosa was about equal to Stockton. The Solano County Fair (SCF) experienced greater decreases. Mr. Reagan said there had been some decrease in handle but staff still could not make hard conclusions regarding the impact of ADW. Commissioner Harris asked if ADW was included in the off-track handle. Mr. Reagan said the numbers were exclusive of ADW. To keep the CHRIMS database operating efficiently ADW numbers were reported separately. When ADW numbers were determined to be accurate and the software was working efficiently, the handle information would be merged. Mr. Reagan added, however, ADW would probably always be reported as a separate item. Craig Fravel, representing CHRIMS, said ADW software development process proved to be very difficult, but he was confident CHRIMS was nearing the end of its transition period. Mr. Fravel said he asked CHRIMS staff to develop a monthly report format that would have a simple but comprehensive detail of not only ADW handle, but

of virtually every component of year-to-date activity. He stated such a report would soon be available by logging onto the CHRIMS web site, or via e-mail to interested parties. Vice-Chairman Licht said he spent a lot of time on the back side at HP during its meeting. He stated the two comments he heard most often had to do with HP's main track and its turf course. He asked if HP had heard anything regarding the two tracks, and if there were plans to address the issues. Eual Wyatt of HP said his organization was aware of the comments and found them disconcerting. He stated HP had just finished resodding the turf course. Some work was done on the growing medium, which would hopefully make it a kinder course. Mr. Wyatt said HP was in the process of determining what steps to take on the main track. Hollywood Park would take action prior to the commencement of its meeting. Vice-Chairman Licht asked if there had been any consideration regarding eliminating synthetic fiber completely from the track. Mr. Wyatt said it was a consideration, but HP was not convinced it should be eliminated. Commissioner Harris asked if HP and Santa Anita had been working to achieve similar tracks. He stated the two different kinds of tracks were a problem in Southern California. Horses were training on one track and running on the other, then reversing the situation when the meetings changed. Mr. Wyatt said he did not know if it would be possible as Santa Anita had threats of heavy rain in the summer, and HP did not. He stated the track superintendents communicated a lot, but he did not know if they tried to develop similar tracks. Ed Halpern of California Thoroughbred Trainers (CTT) said he often heard from trainers regarding their concerns over the tracks. It was difficult to be specific about a particular track as the range of opinions was always wide. However, he stated during the recent HP meeting and subsequent training period, there had been an unusual number of comments from trainers regarding the quality of the track. Mr. Halpern stated he spoke with

HP management regarding the number of comments he had received and they were cooperative. Commissioner Harris said there must be a way to quantify the hardness, the degree of moisture, or other factors. Mr. Halpern said there were test that would measure such things, but with all the science and testing, the answer sometimes involved an intrinsic awareness of the track. Mr. Wyatt said HP had equipment to measure the track's moisture on a daily basis as well as a "clay hammer" that gave readings on the hardness of the course. He stated HP's quandary was tests revealed the track had not changed from 2001. Mr. Wyatt said HP was working with the trainers to determine what the problem was and would hopefully come up with a solution. Chris Korby of California Authority of Racing Fairs (CARF) said the 2002 fairs generally tended to be up in attendance. He stated he believed the drop in handle reflected a downturn in the regional economy. Mr. Korby said CARF increased its outreach promotion program to attract new patrons. He stated CARF was working with the California Marketing Committee's Golden Rewards program, which was generating good results. Regarding SCF, on-track attendance dipped in 2002 compared to 2001. Mr. Korby stated he believed that was due to a significant change in the calendar between the two years. The fair previously coincided with the closing week of HP and the opening of Del Mar, which meant it had 12 days of overlap with Southern California racing. Mr. Korby said CARF was also interested in ADW's impact on the fairs. He stated from the preliminary data there had been steady growth in ADW handle since the three ADW vendors began offering wagering on the fairs' product.

STAFF UPDATE ON THE ADVANCE DEPOSIT WAGERING HANDLE.

John Reagan, CHRB staff, said the Advance Deposit Wagering (ADW) handle had grown to 82.6 million dollars, which was 6.25 percent of the total California handle to date. Mr. Reagan stated ADW was growing steadily as a method of placing a wager, and as a percentage of the entire California handle.

REPORT ON THE IMPLEMENTATION OF ADVANCE DEPOSIT WAGERING.

Ed Hannah of XpressBet said wagering by California residents since the inception of his organization's California hub represented 90 percent of wagers placed. Of its accounts in the California hub, 9,477, or 84.9 percent of the total were with California residents. As of August 4, 2002, total wagering through the California hub was just under 25 million dollars. XpressBet's accounts were acquired through: 74 percent via telephone, fax or Internet; 16 percent opened at Santa Anita; five percent each at Bay Meadows and Golden Gate Fields. The handle per track was: 36 percent wagered on Santa Anita; nine percent wagered on Bay Meadows; eight percent wagered on Golden Gate Fields; and 47 percent wagered on other tracks available on the XpressBet system. The weekly handle for the California hub had stabilized in the \$200,000 to \$300,000 range. Mr. Hannah said the numbers were low because other than the fairs, XpressBet did not have any California content. The interest accrued to the benefit of backstretch charities and welfare funds was \$6,197 through August 4, 2002. The funds would be remitted in January, 2003, as required by law. Mr. Hannah reviewed XpressBet's negotiations with broadcasters in Southern and Northern California. He stated it

was difficult to advance negotiations with many of the cable operators due to turmoil in the industry or prospective mergers.

John Hindman of TVG said his organization's handle to date was nearly \$50 million. TVG currently had 16,000 subscribers, of which 2,000 were added during the Del Mar meeting. The average rate of growth in TVG's handle beginning February 2002 was 53 percent a month. The average rate of growth in subscribers was 48 percent a month. During the Hollywood Park meeting TVG handled \$16 million, and to date nearly \$8 million at Del Mar. Mr. Hindman reviewed TVG's media exposure as well as its future media plans. He stated video streaming had been successfully launched and was popular with subscribers as its use was higher than anticipated. Mr. Hindman said TVG's wagering systems continued to perform well with a 99 percent success rate in processing wagers and less than .1 percent of down time. Mr. Hindman said the Oregon commission eliminated the quarter percent tax on wagers made through the California hub. He stated the money would go into the market access fees, which were split between racetracks and horsemen according to law. Vice-Chairman Licht asked if the default on the Del Mat Internet site helped TVG open accounts. Mr. Hindman said TVG's vice president of marketing was pleased with the numbers. Vice-Chairman Licht asked of a lot of the new accounts were opened to get access to the video streaming and never funded. Mr. Hindman said his organization was monitoring such accounts as it was not beneficial for it or its credit card partners to supply the service. He stated TVG found those who did sign up were funding their accounts and were wagering. Chairman Landsburg read a memorandum into the record regarding the Oregon Racing Commission's deliberations and decision to eliminate its quarter percent tax on ADW wagers made by TVG's California patrons. Commissioner Sperry said he watched with interest TVG's progress and felt it's television

program helped racing considerably. He stated however, TVG's recent wrestling challenge did not, in his opinion, benefit racing at all. Commissioner Sperry said it took away from the entire program, and meant three live races were not shown. Mr. Hindman said TVG tried to look at both sides of the equation. He stated it staged such events occasionally to attract a non-traditional audience.

Joe Hasson of **YouBet.com** (YouBet) said his organization processed over 11,000 telephone calls in July 2002, and over 1.2 million dollars in wagers. YouBet added 1,000 California customers to its California base in July; 5,000 since its licensing in February 2002. Mr. Hasson said Local 280 ratified its contract with YouBet, so the live operator workstations in its offices would be launched September 2002. The handle from the California fairs was steadily growing, with the exception of Ferndale, which overlapped with the San Mateo County Fair. Subsequent to the Fresno Fair, Youbet planned to present a report and analysis of its comarketing efforts with CARF. Mr. Hasson presented slides representing the wagering patterns of YouBet's customers, and the results of the various meetings it offered. He also showed slides designed to provide a comparison of the value YouBet brought to California horse racing vs. other entities. Vice-Chairman Licht asked Mr. Hasson to explain what "RGS" was. Mr. Hasson said "RGS" was an account wagering organization based in the British Virgin Islands. Vice-Chairman Licht asked if RGS' services could be provided by California's licensed ADW providers. Mr. Hasson said California's ADW providers could provide better services. YouBet provided online streaming and race results, as well as other information to customers. In addition, it contributed a significant amount of money to fund TVG's television production. He stated RGS did not do any such things for horse racing in California. Although RGS brought in a lot of handle, the proceeds for horsemen was low: \$375,000 on

\$16 million in wagers, versus YouBet's \$100,000 on \$3 million in wagers. Vice-Chairman Licht said RGS stated it was not taking wagers from California residents, and claimed it would not be in business if it were not able to rebate 10 percent on each dollar wagered. He said he felt the service that YouBet and its two competitors provided were vastly superior to those of the off-shore providers. Mr. Hasson said YouBet agreed with Vice-Chairman Licht, and recommended the Board consider looking at methods of cutting off offshore gambling as customers were transferring money into the offshore accounts then wagering back into the states. Chuck Champion of YouBet said he believed the questions raised by Vice-Chairman Licht were appropriate, but he did not want to represent YouBet as expert on offshore gaming or RGS. Mr. Champion said YouBet was engaged in researching how entities such as RGS affected it. He stated there was evidence to suggest offshore wagering patrons were using YouBet to facilitate their handicapping; downloading products, watching videos, then placing wagers offshore to receive nine or 13 percent in rebates. Vice-Chairman Licht said he believed YouBet was not unique as TVG and XpressBet had the same experience. He stated California needed to look at rebates, or cutting off those entities who offered rebates as such competition was unfair. Vice-Chairman Licht said the long-term issue was whether California allowed its licensees to compete with the off-shore entities, or find a way to cut them off. He stated California had the best product and deep pools that allow for sizeable wagers, which could not be made in many locations. Mr. Hannah said XpressBet believed a lot of patrons were deriving handicapping information from product or other industry-available product and using it to place wagers through an offshore entity that offered rebates. Mr. Hannah commented at the 2001 University of Arizona conference evidence was presented which demonstrated offshore rebate entities had resources that probably exceeded the combined after-

tax income of Magna Entertainment Corporation and Churchill Downs combined. XpressBet agreed rebating offshore entities were a serious issue for the entire industry. Commissioner Harris said he was bothered that Magna Entertainment and Churchill Downs had not followed up on the offshore advertising in the Daily Racing Form (DRF). Craig Fravel of Del Mar Thoroughbred Club said he spoke to the publisher of DRF about the issue of offshore advertising. He stated the publisher indicated a willingness to revisit the issue and spoke about forming a national committee to discuss it. Mr. Fravel said offshore advertising was a source of revenue for DRF, but he did not think it was substantial. Sherwood Chillingworth of Oak Tree Racing Association said he recently attended a conference with representatives of almost every track in the United States. He stated the rebate issue was discussed with the conclusion that associations had to cut off the signal to entities who were rebating and not paying their fair share back to the industry. Mr. Chillingworth said the Thoroughbred Racing Association would soon issue a report on the issue.

REPORT FROM THE RACE DATES COMMITTEE.

Commissioner Harris said the committee met on July 26, 2002, and received comments on the proposed racing schedule for 2003. He outlined the various discussions regarding the 2003 schedule and stated the final issue to be resolved was the conflict regarding Bay Meadows' overlap with Stockton and Sacramento. Commissioner Harris said the issue was not resolved, but would be discussed again at the next committee meeting.

GENERAL BUSINESS

Chairman Landsburg asked Commissioner Harris to comment regarding a race involving the mule Black Ruby. Commissioner Harris said Black Ruby was a ten year old female mule who has won 47 out of 53 races and was widely publicized in the media. Black Ruby was entered to race at Ferndale on Sunday, August 18, 2002. Due to publicity, Ferndale asked the CHRB to limit wagering to win and exotic wagering only. The request was approved. Commissioner Harris said a problem developed when Del Mar decided not to take the race; not to put the race in its program; and not to allow wagering on it. Del Mar took the action despite there being only win and exotic wagering on the race. Commissioner Harris said the idea behind limiting the type of wagering was to eliminate the chance of a minus pool, and as it turned out, there was no minus pool. He stated he believed Del Mar's actions were misinformed as the race had significance to a lot of horse people and fans. Commissioner Harris added Del Mar's action may have been illegal as the association could not pick and choose which races it would take without CHRB approval. He stated he believed the industry needed to work together and be more sensitive to what the public wanted, and what it could do to publicize racing. Although Black Ruby was a mule, there was still a lot of fan interest in the animal. Craig Fravel of Del Mar Thoroughbred Club (DMTC) said the issue dated back to the 2001 race meet at DMTC. In 2001, DMTC had close to a half million dollar net impact as a result of minus pools in the Southern zone on wagers on minor breed races from the Northern pool. Mr. Fravel said in 2001 he consulted with the stewards, and CHRB executive staff regarding DMTC's obligations under the law. He stated he concluded the law was permissive and DMTC had the option of refusing to take wagers on some races. Mr. Fravel stated in 2001 DMTC did not take wagers

in two instances and had continued to judiciously refuse wagers on occasion. He said DTMC planned to hold a match race with Black Ruby and Taz the week after Labor Day. As a thoroughbred track DMTC's primary interest was to make sure thoroughbred purses were not impacted, and that is why it did not take wagers on the race in question. Commissioner Harris said DMTC could have worked with Ferndale to have only exotic wagering with no win only pool. Mr. Fravel said that would have been a good solution. He stated he believed that with the win pool there was only a two-tenths pay out. The position DMTC took regarding the law was that it was permissive, but if a race was taken, DMTC was stuck with the wagering format of the host association. Mr. Fravel said the issue was not limited to Del Mar as other tracks and the horsemen had an interest.

OLD BUSINESS

Chairman Landsburg said during the June 26, 2002, Regular Board Meeting a suggestion was made to undertake further discussions regarding moving the Fairplex meeting to Santa Anita. He asked if the Board felt it should be discussed. Vice-Chairman Licht said the issue should go before the Dates Committee. The Board needed more information on the issue as it was a problem that would return and he wanted to be prepared. Commissioner Moretti said due to the money and complex issues raised she was not sure the issue would fit on the agenda of a Regular Board Meeting. If Fairplex wished to continue the discussion, it should be set as a separate meeting. Mike Seder of Fairplex said his organization would be happy to work with the Board on the issue. He stated Fairplex had not abandoned its interest in moving and would still like to do what it considered would be in the best interest of horse racing. During the

current Fairplex meeting Mr. Seder said his organization would conduct surveys of patrons and the horsemen to determine their views. At the end of the meeting Fairplex hoped to have more information to share with the Board. Commissioner Harris said there was a lot of concern on the backstretch and with fans regarding the accuracy of reporting workouts. Commissioner Harris said the issue had been discussed in the past, and workouts were under the Board's oversight. He stated he believed the public should have confidence the Board was trying to provide correct information. Sherwood Chillingworth of Oak Tree Racing Association (OTRA) said he was on the management committee of Equibase Corporation – which was working with a company that did satellite positioning. He stated the company was using the technology with NASCAR racing and was working to develop it for horse racing purposes. Mr. Chillingworth said one of the problems with the technology was making sure the right transmitter was on the correct horse. It was easy to accomplish during a race as the transmitters could be attached to the jockey's uniform, but it would be more difficult during the morning works. Mr. Chillingworth said he requested a copy of the proposed lease agreement between Fairplex and Los Angeles Turf Club (LATC), which Deputy Attorney General (DAG) Tom Blake stated was a public document; however, the document was returned to LATC. Mr. Chillingworth said he believed he was entitled to receive a copy of the lease as it was declared a public document. Frank De Marco of LATC said the DAG declared the lease agreement between OTRA and LACT a public document. He stated the issue was raised in connection with Fairplex Park's request to change its venue, not in connection with an application for license. Deputy Attorney General Blake said there was a question regarding whether information could be submitted to the Board in confidence; and where it was decided it could not be kept in confidence, the information was withdrawn. If the Board was not in

possession of a document, there would be no application of the Public Records Act. Mr. Blake stated he believed the lease was going to be submitted and made part of the record, but the parties changed their decision, so it was returned. He said in the future, documents submitted to the Board would be looked at to determine if the information contained in them would be made available upon request. Lee Hall of the Service Employees International Union (SEIU) said his union submitted information regarding New World Services (NWS) at Hollywood Park and was waiting for a response from staff. Mike Martin, CHRB staff, said he received information from the SEIU and had arranged for a meeting with NWS to discuss the issue.





NOTICE TO APPLICANT All funds generated and retained from on-track pari-mutuel handle which are obligated by law for distribution in the form of purses, breeders’ awards or other benefits to horsemen, shall not be deemed as income to the association and shall, within 3 calendar days following receipt, be deposited in a segregated and separate liability account in a depository approved by the CHRB and shall be at the disposition of the Paymaster of Purses, who shall pay or distribute such funds to the persons entitled thereto. All funds generated from off-track simulcast wagering, interstate wagering, and out-of-state wagering which are obligated by law for distribution in the form of purses and breeders’ awards, shall also be deposited within 3 calendar days following receipt, into such liability account. **STAFF ANALYSIS
INCREASING THE STABLING AND VANNING TAKEOUT**

**REGULAR BOARD MEETING
SEPTEMBER 25, 2002**

Background:

The California racing industry has been seeking a solution to the worker's compensation issue for several years now. During the recent legislative session, AB 2931 was sent to the Governor. Current law allows the Board to increase the Stabling and Vanning takeout to 1.25% but only for the purposes of offsetting the costs of stabling and vanning. This bill would allow the industry to utilize, subject to certain conditions, a portion of the Stabling and Vanning fund for worker's compensation insurance.

These additional monies from the handle would come in equal shares from the thoroughbred purses and track commissions. The pending legislation does not specify an exact method of using the additional funds for worker's compensation. However, it will take several months to accumulate the first significant funds from the handle for this purpose and it must be assumed that the industry will have decided upon a course of action by that time.

Recommendation:

Staff recommends that the Board hear from interested parties regarding this matter.

CHAPTER _____

An act to amend Sections 19605.73 and 19613 of, and to add Section 19607.4 to, the Business and Professions Code, relating to horse racing, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

AB 2931, Horton. Horse racing.

(1) Existing law permits racing associations, fairs, and the organization responsible for contracting with racing associations and fairs with respect to the conduct of racing meetings, to form a private, statewide marketing organization to market and promote thoroughbred and fair horse racing. Existing law requires the marketing organization to annually submit to the California Horse Racing Board a statewide marketing and promotion plan for thoroughbred and fair horse racing. Existing law also specifies distributions to be distributed to the marketing organization for the promotion of thoroughbred and fair horse racing.

This bill would specify that the marketing organization may also obtain, provide, or defray the cost of workers' compensation coverage for stable employees and jockeys of thoroughbred trainers. This bill would require the marketing organization to annually submit a thoroughbred trainers' workers' compensation defrayal plan for thoroughbred and fair horse racing to the board. This bill would permit specified funds distributed to the marketing organization to be used to defray the cost of workers' compensation coverage for stable employees and jockeys of thoroughbred trainers.

(2) Existing law provides that when satellite wagering is conducted on thoroughbred races, an amount not to exceed 1.25 percent of the total amount handled by satellite wagering facilities shall be deducted, for specified purposes, from specified funds and distributed to an organization formed and operated by thoroughbred racing associations, fairs conducting thoroughbred racing, and the organization representing thoroughbred horsemen.

This bill would permit any amount up to an amount equal to the difference between the 1.25 percent of the total amount handled by satellite wagering facilities, and the amount actually deducted, not

to exceed \$4,000,000 statewide annually, to be utilized to obtain, provide, or defray the cost of workers' compensation coverage for licensed thoroughbred stable employees and jockeys, and an amount not to exceed \$1,000,000 statewide annually, to be paid to a welfare fund established for the benefit of horsemen and backstretch personnel if a written agreement between the owners' organization and certain racing associations and fairs regarding the use of those funds is entered into, and the agreement is filed with the board. This bill would make that agreement binding on the owners' organization and all of the racing associations and fairs that conduct thoroughbred races in California. This bill would give the board the authority to enforce the agreement.

(3) Existing law requires specified sums to be paid to or for the benefit of horsemen at a racing meeting.

This bill would specify that paying those sums to or for the benefit of the horsemen at the racing meeting may include obtaining, providing, or defraying the cost of workers' compensation coverage for stable employees and jockeys of licensed trainers.

This bill would declare that it is to take effect immediately as an urgency statute.

The people of the State of California do enact as follows:

SECTION 1. Section 19605.73 of the Business and Professions Code is amended to read:

19605.73. (a) Racing associations, fairs, and the organization responsible for contracting with racing associations and fairs with respect to the conduct of racing meetings, may form a private, statewide marketing organization to market and promote thoroughbred and fair horse racing, and to obtain, provide, or defray the cost of workers' compensation coverage for stable employees and jockeys of thoroughbred trainers. The organization shall consist of the following members: two members, one from the northern zone and one from the combined central and southern zones, appointed by the thoroughbred racetracks; two members, one from the northern zone and one from the combined central and southern zones, appointed by the owners' organization responsible for contracting with associations and fairs with respect to the conduct of racing meetings; and two members, one from the

northern zone and one from the combined central and southern zones, appointed by the organization representing racing and satellite fairs.

(b) The marketing organization formed pursuant to subdivision (a) shall annually submit to the board a statewide marketing and promotion plan and a thoroughbred trainers' workers' compensation defrayal plan for thoroughbred and fair horse racing that encompasses all geographical zones in the state, and which includes the manner in which funds were expended in the implementation of the plan for the previous calendar year. The plan shall be implemented as determined by the organization. The organization shall receive input from all interested industry participants and may utilize outside consultants in developing the annual marketing plan.

(c) In addition to the distributions specified in subdivisions (a) and (b) of Section 19605.7, and in Sections 19605.71 and 19605.72, for thoroughbred and fair meetings only, from the amount that would normally be available for commissions and purses, an amount equal to 0.4 percent of the total amount handled by each satellite wagering facility shall be distributed to the statewide marketing organization formed pursuant to subdivision (a) for the promotion of thoroughbred and fair horse racing and to defray the cost of workers' compensation coverage for stable employees and jockeys of thoroughbred trainers. Not more than one-sixth of the total amount available annually pursuant to this subdivision shall be used to defray the cost of workers' compensation insurance. Any of the promotion funds that are not expended in the year in which they are collected may be expended in the following year. If promotion funds expended in any one year exceed the amount collected for that year, the funds expended in the following year shall be reduced by the excess amount.

(d) This section shall become inoperative on July 1, 2004, and, as of January 1, 2005, is repealed, unless a later enacted statute that is enacted before January 1, 2005, deletes or extends the dates on which it becomes inoperative and is repealed. Any moneys held by the organization shall, in the event this section is repealed, be distributed to the organization formed pursuant to Section 19608.2, for purposes of that section.

SEC. 2. Section 19607.4 is added to the Business and Professions Code, to read:

19607.4. (a) Notwithstanding any other provision of law, any amount up to an amount equal to the difference between the maximum deduction authorized pursuant to Sections 19607 and 19607.2 and the amount actually deducted, not to exceed four million dollars (\$4,000,000) statewide annually, may be utilized to obtain, provide, or defray the cost of workers' compensation coverage for licensed thoroughbred stable employees and jockeys, and an amount not to exceed one million dollars (\$1,000,000) statewide annually, may be paid to the thoroughbred welfare fund described in subdivision (b) of Section 19641 from the funds described in Sections 19607 and 19607.2, provided (1) there is a written agreement between the owners' organization described in subdivision (a) of Section 19613 and those racing associations and fairs that annually conduct in California at least 75 percent of the thoroughbred races regarding the utilization of those funds; and (2) the agreement is filed with the board.

(b) The agreement shall be binding upon the owners' organization and all of the racing associations and fairs that conduct thoroughbred races in California and the board shall have the authority to enforce the terms of the agreement. The board shall not, however, have the authority to impose an agreement upon the owners' organization or the group of racing associations or fairs described herein.

SEC. 3. Section 19613 of the Business and Professions Code, as amended by Section 11 of Chapter 198 of the Statutes of 2001, is amended to read:

19613. (a) Except as provided in subdivisions (b), (c), (d), (e), and (f), the portion deducted for purses pursuant to this chapter shall be paid to or for the benefit of the horsemen at the racing meeting, and may include obtaining, providing, or defraying the cost of workers' compensation coverage for stable employees and jockeys of licensed trainers.

(b) Any association other than a fair that conducts a thoroughbred racing meeting shall pay to the owners' organization contracting with the association with respect to the conduct of racing meetings for administrative expenses and services rendered to owners, an amount not to exceed two-thirds of 1¹/₂ percent of the portion, and to a trainers' organization for administrative expenses and services rendered to trainers and backstretch employees an amount equivalent to one-third of 1¹/₂ percent of the

portion. That association shall also pay an amount for a pension plan for backstretch personnel to be administered pursuant to Section 19613.8 equivalent to an additional 1 percent of the portion. The remainder of the portion shall be distributed as purses.

(c) Any other association may pay to the horsemen's organization contracting with the association with respect to the conduct of racing meetings for administrative expenses and services rendered to horsemen an amount out of the portion as may be determined by the association by agreement or otherwise, but, in all events, shall include, relative to a thoroughbred horsemen's organization racing, 1 percent of the portion for a pension plan for backstretch personnel pursuant to Section 19613.8. The remainder of the portion shall be distributed as purses.

(d) Notwithstanding subdivisions (b) and (c), any association conducting a fair racing meeting or conducting a mixed breed racing meeting shall pay to the horsemen's organizations contracting with the association with respect to the conduct of races for their respective breeds of horses at the meetings for administrative expenses and services rendered to their respective horsemen those amounts out of the portion as determined by the horsemen's organization for the respective breeds with the approval of the board.

Pursuant to this subdivision, amounts not to exceed 3 percent of the portion for the owners' and trainers' organizations shall be distributed to any thoroughbred owners' and trainers' organizations contracting with an association for a fair racing meeting or participating in mixed breed racing meetings as follows: two-thirds of 1 percent to the owners' organization and one-third of 1 percent to the trainers' organization for administrative expenses and services rendered to both owners and trainers, 1 percent for welfare funds, and 1 percent for a pension program for backstretch personnel, to be administered pursuant to Section 19613.8.

(e) Any association other than a fair that conducts a quarter horse racing meeting, except a mixed breed meeting, shall pay to the horsemen's organization contracting with the association with respect to the conduct of racing meetings for administrative expenses and services rendered to horsemen, an amount not to

exceed 3 percent of the portion. The remainder of the portion shall be distributed as purses.

(f) For racing meetings other than thoroughbred meetings, if no contract has been signed between the association conducting the racing meeting and the organization representing the horsemen by the time the racing meeting commences, the distribution of purses shall be governed by the following:

(1) If the association conducted a racing meeting within the past 15 months and a contract was in existence for that meeting with the horsemen's organization and the association is conducting a subsequent meeting for the same breed or mixed breeds, the amounts payable to the horsemen's organization under subdivision (c) shall be computed under the provisions of the last signed contract between the parties.

(2) This subdivision applies regardless of the cause of the failure to execute a contract, whether that failure is a result of inadvertence or otherwise.

(3) For racing meetings that do not come within paragraph (1), the board shall, within 15 days after the commencement of the racing meeting, determine the amounts payable to the horsemen's organization for administrative expenses and services, and provide for the direct payment of those amounts.

(g) Amounts distributed pursuant to this section are derived from owners' purses.

(h) For the purposes of this section, the following definitions shall apply:

(1) "Owner" means a person currently licensed by the board as an owner of a thoroughbred racehorse.

(2) "Trainer" means a person currently licensed by the board as an owner and trainer or as a trainer of a thoroughbred racehorse.

This section shall remain in effect only until January 1, 2008, and as of that date is repealed, unless a later enacted statute, that is enacted before January 1, 2008, deletes or extends that date.

SEC. 4. Section 19613 of the Business and Professions Code, as added by Section 11.5 of Chapter 198 of the Statutes of 2001, is amended to read:

19613. (a) Except as provided in subdivisions (b), (c), (d), (e), and (f), the portion deducted for purses pursuant to this chapter shall be paid to or for the benefit of the horsemen at the racing meeting, and may include obtaining, providing, or defraying the

cost of workers' compensation coverage for stable employees and jockeys of licensed trainers.

(b) Any association other than a fair that conducts a thoroughbred racing meeting shall pay to the owners' organization contracting with the association with respect to the conduct of racing meetings for administrative expenses and services rendered to owners, an amount not to exceed two-thirds of $1\frac{1}{2}$ percent of the portion, and to a trainers' organization for administrative expenses and services rendered to trainers and backstretch employees an amount equivalent to one-third of $1\frac{1}{2}$ percent of the portion. That association shall also pay an amount for a pension plan for backstretch personnel to be administered by the trainers' organization equivalent to an additional 1 percent of the portion. The remainder of the portion shall be distributed as purses.

(c) Any other association may pay to the horsemen's organization contracting with the association with respect to the conduct of racing meetings for administrative expenses and services rendered to horsemen an amount out of the portion as may be determined by the association by agreement or otherwise, but, in all events, shall include, relative to a thoroughbred horsemen's organization racing, 1 percent of the portion for a pension plan the trainers' organization. The remainder of the portion shall be distributed as purses.

(d) Notwithstanding subdivisions (b) and (c), any association conducting a fair racing meeting shall pay to the horsemen's organizations contracting with the association with respect to the conduct of races for their respective breeds of horses at the meetings for administrative expenses and services rendered to their respective horsemen those amounts out of the portion as determined by the horsemen's organization for the respective breeds with the approval of the board. Pursuant to this subdivision, amounts not to exceed 3 percent of the portion for the owners' and trainers' organizations shall be distributed to any thoroughbred owners' and trainers' organizations contracting with an association for a fair racing meeting or participating in mixed breed racing meetings as follows: two-thirds of 1 percent to the owners' organization and one-third of 1 percent to the trainers' organization for administrative expenses and services rendered to both owners and trainers, 1 percent for welfare funds, and 1

percent for a pension program for backstretch personnel, to be administered by the thoroughbred trainers' organization.

(e) Any association other than a fair that conducts a quarter horse racing meeting shall pay to the horsemen's organization contracting with the association with respect to the conduct of racing meetings for administrative expenses and services rendered to horsemen, an amount not to exceed 3 percent of the portion. The remainder of the portion shall be distributed as purses.

(f) For racing meetings other than thoroughbred meetings, if no contract has been signed between the association conducting the racing meeting and the organization representing the horsemen by the time the racing meeting commences, the distribution of purses shall be governed by the following:

(1) If the association conducted a racing meeting within the past 15 months and a contract was in existence, for that meeting with the horsemen's organization and the association is conducting a subsequent meeting for the same breed or mixed breeds, the amounts payable to the horsemen's organization under subdivision (c) shall be computed under the provisions of the last signed contract between the parties.

(2) This subdivision applies regardless of the cause of the failure to execute a contract, whether that failure is a result of inadvertence or otherwise.

(3) For racing meetings that do not come within paragraph (1), the board shall, within 15 days after the commencement of the racing meeting, determine the amounts payable to the horsemen's organization for administrative expenses and services, and provide for the direct payment of those amounts.

(g) Amounts distributed pursuant to this section are derived from owners' purses.

(h) For the purposes of this section, the following definitions shall apply:

(1) "Owner" means a person currently licensed by the board as an owner of a thoroughbred racehorse.

(2) "Trainer" means a person currently licensed by the board as an owner and trainer or as a trainer of a thoroughbred racehorse.

(i) This section shall become operative on January 1, 2008.

SEC. 5. This act is an urgency statute necessary for the immediate preservation of the public peace, health, or safety

within the meaning of Article IV of the Constitution and shall go into immediate effect. The facts constituting the necessity are:

On July 1, 2002, the cost of workers' compensation coverage for horse trainers rose by 30 to 60 percent. In order to immediately authorize use of specified funds to assist in offsetting the increased cost of workers' compensation coverage, so that horse trainers do not let their coverage lapse or leave the state, resulting in the state lacking sufficient numbers of properly insured horse trainers, it is necessary that this act take effect immediately.

SCRATCHED HORSE IN CLAIMING RACE

Regular Board Meeting

BACKGROUND

Business and Professions (B&P) Code Section 19420 states jurisdiction and supervision over meetings in California where horse races with wagering on their results are held or conducted, and over all persons or things having to do with the operation of such meetings, is vested in the California Horse Racing Board. B&P Code Section 19440 provides that the responsibilities of the Board shall include adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering.

A horse entered to race may be scratched as late as the post parade or at the starting gate by the official veterinarian. Currently, horses that are scratched from a claiming race may be entered back in a non-claiming race, or a claiming race with a higher value as soon as it is deemed fit to run. This could be advantageous to those who may wish to prevent their horse from being claimed out of a claiming race. With no restrictions on the races in which a scratched horse is able to run back, allegations of collusion to avoid a claim occasionally surface when a horse that may be claimed is scratched for being unsound.

ANALYSIS

The proposed addition of Rule 1668, Scratched Horse in Claiming Race, is modeled after harness racing policy wherein a horse that is scratched from a claiming race may not be entered back in another claiming race for 30 days unless it is in a race of lesser or equal value. The proposed Rule 1668 would prohibit a horse that has been scratched from a claiming race from being entered in a subsequent claiming race for a period of 60 days from the date of the scratch unless it is entered in a claiming race of the same, or lower price. Under the proposed rule scratching a horse from a claiming race for other than legitimate reasons would be discouraged.

RECOMMENDATION

Staff recommends the Board instruct staff to initiate the 45-day public comment period.








HANDLE VS. ATTENDANCE



DISTRIBUTION OF HANDLE
































HANDLE VS. ATTENDANCE



DISTRIBUTION OF HANDLE


