The Supervising Special Investigator I is a peace officer position pursuant to Penal Code 830.3(d). POSITION DESCRIPTION:

Under the general direction of the Chief, Licensing and Enforcement, the Supervising Special Investigator I, plans, organizes, supervises, and evaluates a staff of Investigators in (1) field investigations to detect or verify suspected violations of California Horse Racing laws, CHRB rules and regulations, and other related laws; (2) reviews the Investigators' reports in preparation of cases for hearings and/or criminal/civil prosecution and (3) assists with the occupational license process of persons and entities participating in California horse racing.

DESIRABLE QUALIFICATIONS:

Knowledge of or willingness to learn about race horses; the common procedures and practices that are used in the horse racing industry; ability to gain the respect and trust of the horse racing industry; knowledge of drug enforcement practices; knowledge of the veterinary practices used in the horse racing industry; background investigative experience; and good report writing, interviewing, and investigative skills. Those with Spanish bilingual skills are encouraged to apply.

SPECIAL PERSONAL CHARACTERISTICS:

Work irregular hours, holidays, and weekends; travel frequently in northern California and occasionally throughout the State. Good writing skills; emotional stability; tact; keenness of observation; good memory for names, faces, and incidents; interpersonal skills; ability to follow directions; ability to work independently and as a team member.

ADDITIONAL INFORMATION:

Other monthly benefits may include Spanish bilingual pay of \$100; Intermediate POST certification of \$50 or Associate degree pay of \$75 or Advanced POST certification of \$100 or Bachelors degree pay of \$125.

| 50% | Plans, organizes, and supervises the performance of field investigative activities; travel to the various race tracks/fair meets to ensure investigative staff are in compliance with applicable Board policies; reviews, evaluates and approves investigative reports for submission to the Chief, Licensing and Enforcement, Commissioners, Executive Staff, and the Board of Stewards; participates in the more complex and/or confidential investigations; writes reports, gathers and preserves evidence; presents cases before the Board of Stewards by proving the facts, questioning prosecution and defense witnesses, presenting evidence for review and acceptance into the hearing and may litigate cases; represents the CHRB/testifies before court hearings and trials; works with and secures the cooperation of racing industry management, Federal, State, and local law enforcement agencies; and takes action on all personnel related issues for his/her assigned staff. |
| 35% | Reviews cases involving violations of laws and rules and assigns cases for investigation; assigns investigative staff to inspect the racing enclosure in its entirety to assure that laws and rules are adhered to; develop and work with confidential informants; and maintain good communication with the horse racing industry. |
| 15% | Assigns staff to inspect simulcast wagering and auxiliary facilities which includes internal and external review of the entire facility; checking licenses of all personnel; assist the Licensing Unit with fingerprinting and other related duties, and performs other duties as required. |
