3/2/12 (1) **Ralph Silvestri Film Review**

Driver Ralph Silvestri appeared in the steward's office to review his drive in the eighth race on Saturday, February 25th. Driver Silvestri sat behind sixth place finisher #8 "Code Blue" in this race Silvestri survived a Steward's inquiry [REF: 2/25/12 (8)] for a possible pylon violation. Silvestri races inside one (1) pylon and struck another pylon in the stretch drive of this race. The stewards felt "Code Blue" was manageable in this race and determined Driver Silvestri steering led to this horse leaving the racetrack. The stewards issued the ruling below:

**RULING # 22**

DRIVER **RALPH SILVESTRI III**, WHO DROVE "**CODE BLUE**" IN THE EIGHTH RACE ON SATURDAY, FEBRUARY 25, 2012 IS HEREBY FINED THE SUM OF FIFTY (**\$50.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # **1721 (K)** (DRIVING RULES – CARELESS DRIVING – RACED INSIDE PYLON – IN THE STRETCH).

3/2/12 (2) **Wagering Change**

Place and show wagering was cancelled and listed as such on tonight's official program. "Alpine Hawk" (Richard Wojcio) finished first in tonight's five (5) horse trotting event. At odds of 3/1.

3/2/12 (3) **Fourth Race Inquiry**

The stewards posted the inquiry sign after viewing an incident that took place immediately after the ¾ pole. Fourth place finisher #1 "Margarita Bi" (John McKeon) and fifth place finisher #3 "Victory Felicia" (Amanda Fraser) hooked wheels and subsequently sashayed in tandem after contact.

The stewards spoke to both drivers involved and viewed all camera shot's of the incident. Unfortunately the 'head-on stretch' camera shot of this incident was very blurry and the stewards were unable to judge off of the camera angle that was most beneficial in this case. Doubt remained following film review as to what led to the 'hooking of wheels'. The steward's unanimously voted to make 'no change' in the order of finish. Provisional Driver Fraser and Driver McKeon were ordered to film review.
