Tim Brown Hearing Case No: 125W0009

A hearing was conducted today concerning a needle and syringe found in Trainer Tim Brown's tack room/office during a routine barn inspection on February 29, 2012. The inspection was conducted by CHRB Investigator Carol Nolan and supervisor Dan Dailey.

Present at the hearing were the Board of Stewards- Wayne Oke, Grant Baker, and William Meyers; Investigator Nolan and Supervisor Dailey whom presented the case; Trainer Tim Brown represented himself; witnesses were CHRB Veterinarian Robert Goodbary and Practicing Veterinarian Audry Clifton. Wendy Frazier recorded the proceedings.

The following undisputed facts arose in the hearing:

1. One (1) syringe with needle attached was found in plain sight in tack room X5 assigned to Trainer Tim Brown.
2. Davis Laboratory confirmed residue in the syringe was consistent with medications used by Veterinarian Audry Clifton who was treating "Hope To Place" in Brown's barn.

All documents and testimony were placed on the record and the hearing was closed. Decision to follow.

Saturday4/28/12 (1) **Third Race Inquiry-Disqualification**

The stewards posted the inquiry sign to review observed interference involving the first place finisher #4 “Ra Ra Steven” (Richard Wojcio) and sixth place finisher #6 “Looks Don’t Count” (James Kennedy). Tapes show #4 comes out in mid turn putting a wheel under #6 and eventually hooking wheel with that rival. The actions of #4 caused Bill Vallandingham and talking to the driver, #4 was unanimously disqualified and placed sixth behind #6. Driver Richard Wojcio will see the stewards on Friday.

4/28/12 (2) **Sixth Race Inquiry-No Change**

The inquiry sign was posted to review possible interference by the fourth place finisher #7 “Arts Spice” (Harold Herrera) to two rivals during the stretch drive. After review it was determined that #7 did interfere with the #3 “Jen’s Delight” (Luke Plano) but no other rival. #3 finished second ahead of #7 so no change was warranted. Drive Herrera was ordered to the Stewards Office.
