- 05/03/13 (1) **Warrington Bute Warning – Case #: 13SW0041**  
Trainer Cliff Warrington Jr. was issued a formal warning following today's hearing. Mr. Warrington trained "Mystery Card" who finished first on March 16, 2013. A post race sample was reported by Maddy Laboratories at U.C. Davis to contain 3.0 UG/ML Phenylbutazone. This was Warrington's first violation in over three years.
- 05/03/13 (2) **Hearing Postponed – Case #: 13SW0016 [CHRB vs Kate Phariss]**  
A hearing scheduled for today was postponed by the stewards in order to have a court reporter present to record the hearing.
- 05/03/13 (3) **Post Time Change**  
Due to only twelve (12) races being carded tonight's first post time was moved from 5:30 to 6:15 PM. This was approved by CHRB Executive Director Kirk Breed on Tuesday and the change made the program.
- 05/03/13 (4) **Sixth Race Inquiry – Refund**  
#7 "More Tequila" (Luke Plano) went off stride approaching the starting gate due to a broken crupper which caused Driver Plano to lose control. Both Plano and outrider Billy Don Wainscott (by walkie talkie) tried to get starter Bill Vallandingham's attention for a recall, but were unsuccessful before the race was off. The inquiry sign was posted and after verification of the broken equipment #7 was declared a non starter. Refunds totaled \$30,547 according to the Mutuel Department.
- 05/03/13 (5) **Eighth Race Inquiry – No Change**  
The inquiry sign was posted to review a possible pylon violation in the stretch by #2 "Mousseline Hanover" (James Lackey) who finished on equal terms for first with #6 "Incredible Gambler." After review it was determined that #2 only hit a pylon and no violation occurred. No change.

05/0413 (2) **Second Race Inquiry – Disqualification**  
 In a majority vote, second place finisher #31 “Regal Attire” (Daniel Gassien) was placed behind third place finisher #4 “Forever My Love” (Tim Maier) for interference very near the finish line. Tapes show #1 come out placing a wheel under #4 causing Driver Maier to steady his mount. Stewards Baker and Oke felt the interference cost #4 a chance to better his position. Steward Meyers felt the incident happened too late to cost #4 a position.
