Proceedings of the Board of Stewards for the period of Monday October 28, 2013 through Sunday, November 3, 2013. Steward William Meyers was the Reporting and Duty Steward for the enclosed period.

10/28/13 (1) **Entries for Friday and Saturday – Draw for Friday**  
Entries were taken for Friday and Saturday's cards. The draw for Friday's races were conducted at approximately 4:00pm with eighty eight (88) horses scheduled to compete in thirteen (13) races. No Cal-Bred races were used.

**Friday**11/01/13 (1) **Siegel Ruling****RULING #2**

DRIVER **DAVID SIEGEL**, WHO DROVE “**ETERNAL OVERDRIVE**” IN THE THIRD RACE ON OCTOBER 26, 2013 AT CAL EXPO, CALIFORNIA, IS HEREBY FINED THE SUM OF ONE HUNDRED DOLLARS (**\$100.00**)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #**1731 (E)** (DRIVER INFRACTIONS – CROSS OVER BEFORE START).

The above ruling was issued after Siegel appeared and reviewed the films with the stewards. Siegel accepted the fact that he could have kept a straighter line behind the gate before the start.

11/01/13 (2) **Fourth Race Inquiry – No Change**

The inquiry sign was posted to review the stretch run in which third place finisher #2 “I O One” ducked inside two pylons. Driver Steve Wiseman had no explanation for the unusual move as #2 was racing in the clear at the time. No unfair advantage or interference was detected and the action did not trigger an automatic disqualification under Cal-Expo’s pylon rules. The stewards were unanimous in making no change to the order of finish.

**Saturday**11/02/13 (1) **Curtin Ruling****RULING #1**

IN THE CASE OF **PATRICIA M. CURTIN**:

HAVING NOW APPEARED, RULING #4 ISSUED AT THE SAN JOAQUIN COUNTY FAIR ON SEPTEMBER 28, 2013 SUSPENDING PATRICIA M. CURTIN IS HEREBY SET ASIDE.

FURTHER EXERCISE RIDER PATRICIA M. CURTIN IS HEREBY SUSPENDED NINETY (90) DAYS COMMENCING NOVEMBER 6, 2013 THROUGH AND INCLUDING FEBRUARY 3, 2014 FOR VIOLATION OF CHR B RULE #**1874** (DISORDERLY CONDUCT – TESTED POSITIVE FOR MARIJUANA).

DURING THE TERM OF SUSPENSION, PATRICIA M. CURTIN IS DENIED ACCESS TO ANY PREMISES IN THIS JURISDICTION PURSUANT TO

CALIFORNIA HORSE RACING BOARD RULE #1527 (GENERAL AUTHORITY OF STEWARDS).

IT IS FURTHER ORDERED THAT PATRICIA M. CURTIN ATTEND A MINIMUM OF TWO MEETINGS A WEEK OF ALCOHOLICS ANONYMOUS AND/OR NARCOTICS ANONYMOUS DURING THE TERM OF SUSPENSION. ).

PATRICIA M. CURTIN MUST SHOW VERIFICATION OF ATTENDANCE TO A BOARD OF STEWARDS TO BE ELIGIBLE FOR RE-INSTATEMENT.

PATRICIA M. CURTIN SHALL BE ON A SIGNED TESTING AGREEMENT FOR THE TERM OF HER LICENSE.

The above ruling was issued following due deliberations over October 19<sup>th</sup>'s hearing. Matters were complicated over Ms. Curtin's license expiring at the end of October. She received a subsequent license which was not valid due to her suspension from the Ruling issued at the San Joaquin Fair. Since the above ruling vacated the San Joaquin ruling her renewed license became valid which allowed the suspension noted in the above ruling. Complicated but finally adjudicated.

- 11/02/13 (2) **Qualifiers**  
Eleven (11) of sixteen (16) made the grade in tonight's three (3) qualifying races.
- 11/02/13 (3) **Unauthorized Access to Racetrack**  
A young girl (approximately three (3) years old) managed to get onto the racetrack in between the third and fourth races. Her mother recovered her in short order within seconds. Luckily no horses were in the vicinity. A chain link gate near the winner circle which is normally chained and padlocked was left unlocked for some reason which allowed the child access. The stewards notified management and security which took immediate action to chain and lock the gate.
