Proceedings of the Board of Stewards for the period of Monday, December 2, 2013 through Sunday, December 8, 2013. Steward Grant Baker was the Reporting and Duty Steward for the enclosed period.

12/02/13 (1) **Entry/ Draw Day**

The racing office was open today accepting entries for Friday, December 6th and Saturday, December 7th. Fifteen (15) races were drawn for December 6th. One hundred nine (109) horses are scheduled to start.

12/02/13 (2) **Dark Day**

12/03/13 (1) **Entry/ Draw/ Scratch Day**

Scratches and changes for Friday, December 6th took place this morning in the racing office. There were no scratches. Fifteen (15) driver changes/selections were made. All changes were activated after the 9:00am deadline. Fifteen (15) races for Saturday, December 7th were drawn in the racing office today. One hundred twelve (112) horses are scheduled to start.

Scratches and changes for Saturday, December 7th were taken today in the racing office. There were no scratches. There were eighteen (18) driver changes/selections. All changes were activated after today's 9:00am deadline.

Driver Luke Plano appeared in the steward's office in order to review his drive in the first race on Saturday, November 30th. Plano drove #2 'Early Boy' who finished fourth in this race for Trainer Gene Vallandingham. The stewards wanted to review the stretch run of this race with Driver Plano who was leaning back in his sulky for the majority of the final 3/16ths of a mile. This was a trotting event and Driver Plano told the stewards he felt his mount was going to 'break' (go offstride) if he urged him in the stretch. He said #2 "Early Boy" felt like he had a "rolling motion." Also in this race Trainer Gene Vallandingham drove and trained stablemate, #4 "Ali De Vie" who finished first as the even money favorite. The stewards told Plano his drive didn't look good despite his explanation. The stewards will obviously always closely monitor the actions of all drivers during the live race and during race replays.

12/06/13 (2) **Karen Isbell Film Review**

Driver Karen Isbell appeared in the steward's office in order to review her drive in the seventh race on Saturday, November 30th. Driver Isbell sat behind #3 "Stiletosilverheels" who finished fifth in this six horse event. Racing down the backstretch, before the ½ mile pole, the helmet of Driver Isbell flies off her head and onto the racing surface. Eventual first place finisher #6 "R Journey Together" swerves alertly in order to avoid the helmet rolling on the track. Driver Isbell told the stewards she had been having problems on prior evenings with the buckle on her helmet. The stewards expressed concern over her safety and also competing horses and drivers in the races. The stewards issued the following ruling:

RULING # 14

DRIVER **KAREN ISBELL**, WHO DROVE "**STILETOSILVERHEELS**" IN THE SEVENTH RACE ON NOVEMBER 30, 2013, IS HEREBY FINED THE SUM OF FIFTY (**\$50.00**)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE **#1689** (SAFETY HELMET REQUIRED – UNFASTENED HELMET BLEW OFF DURING RACE).

12/06/13 (3) **Wagering Pool Problems/ Second Place**

Place and show wagering was originally cancelled for this five (5) horse field in a timely manner, after Watch and Wager.com LLC received permission from the California Horse Racing Board earlier in the week. However, the toteboard tonight showed place and show money in the pools immediately after the first race went official. The stewards contacted Scientific Games Tote Operator Michelle Arendt and Watch and Wager.com LLC General Manager Chris Schick. Eighteen (\$18.00) dollars in place wagers and five hundred twenty six (\$526.00) dollars in show wagers that had been made were immediately refunded. An unusual happening occurred following this race. Following calculations from the tote department, the win pool had a \$222.67 minus pool. #2 "Show Dancer" (Tim Maier) dominated this field at post time odds of one to nine (1/9).

12/06/13 (4) **Tenth Race Recall**

Starter Bill Vallandingham flashed his recall lights prior to the dispatch for the tenth race. #1 "Brewski" (Steve Wiseman) bore out and severely impeded #3 "De Valeria" (Luke Plano) over a furlong before the start. A second attempt at a start went off without a hitch.

Saturday12/07/13 (1) **George Luster Ruling****RULING # 15**

DRIVER **GEORGE LUSTER**, WHO DROVE "**LODI NICKOLUS**" IN THE SEVENTH RACE ON DECEMBER 6, 2013, IS HEREBY FINED THE SUM OF FIFTY (**\$50.00**)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED – VIOLATION OF 'CAL-EXPO HOUSE WHIPPING RULE' – (2) DRIVER MUST KEEP ONE LINE IN EACH HAND AT ALL TIMES UNTIL HORSE REACHES THE 7/8 MARKER).

'Lodi Nickolus' finished second in the seventh race on Friday, December 6th. Driver Luster had an unfair advantage in this race by taking his hand out of his hand hold as he cropped his horse one-handed while 'Lodi Nickolus' was entering the far turn, well before the 7/8 marker where this is allowed. The vote was unanimous.

- 12/07/13 (2) **Qualifying Races**
Four (4) qualifying races were held prior to this evenings fifteen (15) race card. Of the seventeen (17) competitors, all seventeen (17) made the grade.
- 12/07/13 (3) **Second Race Inquiry**
The stewards posted the inquiry sign following this race after viewing fifth place finisher #1 'Southwind Kean' (Marc Mosher) go on a extended break in this races final ninety (90) yards. After film review the stewards determined that #1 'Southwind Kean' complied with the breaking rule. No change.
- 12/07/13 (4) **Tenth Race Inquiry**
The stewards posted the inquiry sign in order to review the actions of #2 "Captain Greg" (Roy Dinges) who finished fourth in this race. Video review shows #2 "Captain Greg" go on a break before and after the start. This horse lost much ground after the break and the stewards unanimously determined that CHRB Rule #1722 (Breaking) was complied with. No change.
