The race office was open this morning accepting entries for Friday and Saturday. At the draw for Friday in ninety one (91) head were drawn to compete in twelve (12) pari-mutuel events. Additionally, three (3) California Sired three (3) year old pacing fillies were drawn to compete in an early non-betting event with post time set for 5:45PM purse of ten thousand dollars (\$10,000.00). California sired three (3) year old pacing colts and geldings were drawn to compete in a five (5) horse field on Friday’s third race for a purse of ten thousand dollars (\$10,000.00).

Driver Mike Jarvis appeared as requested in order to review his drive in Friday's eighth race. At issue was Driver Jarvis use of the whip in the stretch drive. After discussing the situations and reviewing video Driver Jarvis accepted the Stewards opinion and the following ruling was issued.

RULING #47

DRIVER MIKE JARVIS, WHO DROVE "WHATA BIZNESS" IN THE EIGHTH RACE ON FRIDAY, MARCH 25, 2016 AT CAL EXPO, CA IS HEREBY FINED ONE HUNDRED (\$100.00)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED – VIOLATION OF 'CAL-EXPO HOUSE WHIPPING RULE' – (4) (A) ANY BLATANT OR EXAGGERATED MOVEMENTS OF THE WHIPPING ARM WHICH WILL RESULT FROM RAISING THE ELBOW ABOVE THE DRIVER'S SHOULDER HEIGHT AND/OR ALLOWING THE HAND HOLDING THE WHIP TO REACH BEHIND THE DRIVER DURING THE USE OF THE WHIP).

THIS RULING ISSUED PURSUANT TO THE AUTHORITY GRANTED TO THE BOARD OF STEWARDS UNDER CHRB RULE #1870 "CONDITIONS OF MEETING BINDING UPON LICENSEES."

03/26/16 (2) Driver In [Ref: 03/25/16 (5)]

Driver Paul Welence appeared as requested in order to review his drive in Friday's ninth race. At issue was Driver Welence use of the whip in the stretch drive. After discussing the situations and reviewing video Driver Welence accepted the Stewards opinion and the following ruling was issued.

RULING #48

DRIVER PAUL WELENCE, WHO DROVE #5 "HIHO LEGACY" IN THE NINTH RACE ON FRIDAY, MARCH 25, 2016 IS HEREBY FINED THE SUM OF ONE HUNDRED (\$100.00)* DOLLARS FOR VIOLATION OF WATCH AND WAGER LLC HOUSE WHIPPING RULE (DRIVERS MAY NOT USE THE WHIP MORE THAN THREE (3) TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND) AND CHRB RULE #1530 (CASES NOT COVERED). FIRST OFFENSE IN THE LAST SIXTY (60) DAYS.

THIS RULING ISSUED PURSUANT TO THE AUTHORITY GRANTED TO THE BOARD OF STEWARDS UNDER CHRB RULE #1870 "CONDITIONS OF MEETING BINDING UPON LICENSEES."

03/26/16 (3) Driver In [Ref: 03/25/16 (3)]

Driver David Siegel appeared in order to review his drive in Friday's seventh race. The issue was a potential violation of the house whipping rule (drivers may not use the whip more than three (3) times in succession without giving the horse a chance to respond). After reviewing video Driver Siegel took complete responsibility for his actions. The following ruling was issued.

RULING #49

DRIVER **DAVID SIEGEL**, WHO DROVE #5 “**SF LAW**” IN THE SEVENTH RACE ON FRIDAY, MARCH 25, 2016 IS HEREBY FINED THE SUM OF TWO HUNDRED (**\$200.00**)* DOLLARS FOR VIOLATION OF WATCH AND WAGER LLC HOUSE WHIPPING RULE (DRIVERS MAY NOT USE THE WHIP MORE THAN THREE (3) TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND) AND CHR B RULE #1530 (CASES NOT COVERED). SECOND OFFENSE IN THE LAST SIXTY (60) DAYS.

THIS RULING ISSUED PURSUANT TO THE AUTHORITY GRANTED TO THE BOARD OF STEWARDS UNDER CHR B RULE #1870 “CONDITIONS OF MEETING BINDING UPON LICENSEES.”

03/26/16 (4) **Photo Finish Failure**

The photo finish camera failed for the first and third races. In the first race finish the horses were well separated and establishing a correct order of finished was not an issue. In the third race there were two (2) horses on the wire and the Board of Stewards were unable to separate them. Thus according to CHR B Rule #1956 Declared a Dead Heat for Win.

03/26/16 (5) **Second Race/ Inquiry/ No Change**

The inquiry sign was flashed in order to examine the actions of #5 “Six Strings and a Pick” the unofficial fifth place finisher who was observed “offstride” after the start. After reviewing video the Stewards unanimously concluded that #5 complied with the ‘breaking rule’ thus no change. Additionally, #5 interfered with #4 “Kiss the Boys” (Steve Desomer) while offstride. #4 finished ahead of #5 in the official order of finish thus no change.

03/26/16 (6) **Fifth Race/ Driver to Film Review**

After the fifth race Driver James Kennedy was requested to attend film review. At issue is a possible violation of the ‘house whipping rule.’ More to follow.
