

# COMPLAINT

CASE NUMBER: **22LA0053**

The CHRB hereby files a complaint against **Valentin Zamudio** for violation of CHRB Rule **1843(a,b&d), 1843.1(a), 1843.4, 1866 & 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **305492 - 10/2022**. The offense alleged occurred on or about **10/02/2021** and is as follows:

**Official blood sample #NC51450 taken on 02/26/2022 at Los Alamitos from "Set for it" was reported by Ben Moeller, PhD of Maddy EACL at UC Davis contained Dexamethasone. Dexamethasone is a class 4 prohibited drug substance with a penalty class C. The horse, "Set for it" worked on 02/26/2021 at Los Alamitos. The trainer of record is Valentin Zamudio (CHRB Lic# 305492 - 10/2022). The split analysis was not requested in accordance to 1859.25.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
