

# COMPLAINT

CASE NUMBER: **22SA0041**

The CHRB hereby files a complaint against **ED MOGER JR.** for violation of CHRB Rule **1843(a)(b)(d)**, **1843.1(a)**, **1866(h)**, and **1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **058821-04/2025**. The offense alleged occurred on or about **3/10/22** and is as follows:

**The official blood sample #NC44439 taken on March 10<sup>th</sup>, 2022 at Santa Anita Park in Arcadia, CA. was reported by Dr. Ben Moeller, PhD of U.C. Davis Laboratories, contained Phenylbutazone. The sample was obtained from the horse "SQUALOTORO" which performed an official workout at 5F on Dirt. The trainer of record is Ed Moger Jr. This violation is a Class 4 drug with a Penalty Category C.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
