

COMPLAINT

CASE NUMBER: **22DM0041**

The CHRB hereby files a complaint against **Wendy Ruis (Stable: Ruis Racing LLC), Shelbe Ruis, and Drayden Van Dyke** for violation of HISA Rule **2280**. The person named in this complaint holds a license as a **Owner, Trainer, and Jockey**, license number **248848 - 11/30/2024, 321557 - 9/30/2024, and 312720 - 9/30/2025**. The offense alleged occurred on or about **9/9/2022** and is as follows:

On 9/9/2022, CHRB Investigator's were notified that Jockey Drayden Van Dyke (#312720 – 09/30/2025) who rode “BOLT’S BROAD” in the sixth race at Del Mar Racetrack on 9/9/2022 and placed 1st, was observed using his riding crop five times over the limit (Class 2 Violation). The owner is Owner Wendy Ruis (Stable Ruis Racing LLC), Trainer Shelbe Ruis (#321557 – 9/30/2024), and Jockey was Drayden Van Dyke (#312720 – 09/30/2025). In accordance HISA Rule #2282(b), the horse “BOLT’S BROAD” will be disqualified and any purse money forfeited.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
