The CHRB hereby files a complaint against **Clifford Delima** for violation of CHRB Rule **12-Counts of 1878(b)**.

The person named in this complaint holds a license as a **Trainer**, license number **075721-10/23**. The offense alleged occurred on or about **4/16/22** and

is as follows:

Trainer Clifford Delima did not report nor provide a Pre-Work Examination by an authorized CHRB veterinarian for horses AFTER SUNDOWN, MANILA MISCHIEF, NOWHERE MAN, CINDERELLAS PRINCE, BLAZING JAIME, DAISY DANCER, FOXY FAX, IMPRESSIVE CURLS, LITTLE CHEYENNE, PERFECT CURVES, RODEO JOE and SUGAR CRUSH within 72-hours before engaging in official time workouts on 4/16/22.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
