

COMPLAINT

CASE NUMBER: **22LA0178**

The CHRB hereby files a complaint against **Angela Aquino/Henry Lopez** for violation of CHRB Rule **1859.5**.

The person named in this complaint holds a license as a **Trainer/Jockey**, license number **277815 - 07/2025 / 400236 - 07/2023**. The offense alleged occurred on or about **08/07/2022** and

is as follows:

Official blood sample #LA50479 taken on 08/07/2022 at Los Alamitos from "Debt Monger" was reported by Ben Moeller, PhD of Maddy EACL at UC Davis contained Caffeine. Caffeine is a class 2 prohibited drug substance with a penalty class B. The horse, "Debt Monger" raced on 8/7/2022 in the 4th race at Los Alamitos Race Course and finished 1st. It is hereby ordered that "Debt Monger" be disqualified from all purse monies earned and deemed unplaced in accordance with California Horse Racing Board Rule #1859.5 (Disqualification Upon Positive Test Finding). The trainer of record is Angela Aquino, the owner of record is Angela Aquino (CHRB Lic#231136 - 07/2023), and the jockey of record is Henry R. Lopez (CHRB Lic# 400236 - 07/2025). The split analysis was not requested in accordance to 1859.25.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
