

COMPLAINT

CASE NUMBER: **22DM0043**

The CHRB hereby files a complaint against **Lorenzo Ruiz** for violation of CHRB Rule **1843(a)(b)(d), 1843.1(b), 1843.4, and 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **297981 - Exp 8/31/2025**. The offense alleged occurred on or about **9/10/2022** and is as follows:

The official blood sample #DM20072 taken on 9/10/2022, at Del Mar Racetrack was reported by Ben Moeller, PhD of UC Davis Laboratories to contain Phenylbutazone (1.03 ug/ml). The sample was obtained from the horse "MANITOWISH" who placed 3rd in the 2nd race at Del Mar Racetrack on 9/10/2022. The trainer of record is Lorenzo Ruiz (CHRB# 297981 – 08/31/25). A split sample was not requested. The violation is a Class 4 drug with a Penalty Category C.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
