COMPLAINT

CASE NUMBER: 22GG0136

The CHRB hereby files a complaint against **Isidro Tamayo** for violation of CHRB Rules **1843(a), 1843(c), 1843.1(a) and 1887(a)**. The person named in this complaint holds a license as a **Trainer (296084-02/2025)**. The offense alleged occurred on or about **11/25/2022** and is as follows:

On 12/13/2022, the E-mail memorandum from CHRB Split Sample Custodian, Deborah Mendricks, reported that the official blood sample #GG40779 taken on 11/25/2022, at Golden Gate Fields (GGF), from horse "Mistical Surprise", contained Phenylbutazone (Per the UC Davis Maddy Equine Analytical Chemistry Lab, Final Report dated 12/08/2022: "Blood Results PBZ 2.14"). This horse ran in race #1 at Golden Gate Fields on 11/25/2022 and finished 2nd. The trainer of record is Isidro Tamayo. Phenylbutazone is a Class 4/Penalty Class 'C' violation.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
