

# COMPLAINT

CASE NUMBER: **23GG0020**

The CHRB hereby files a complaint against **Eoin G. Harty** for violation of CHRB Rule **1840, 1842.5, 1843(a), 1843(d), 1843.1(a), 1843.3(a), 1843.4, and 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **066943-11/25**. The offense alleged occurred on or about **02/03/23** and is as follows:

**The official blood sample #GG41231 taken on 2/03/23 at Golden Gate Fields was reported by Ben Moeller, PhD of UC Davis Laboratory to contain (0.5) Phenylbutazone: class 4/C. This sample was obtained from the horse El Joy which ran in race #4 at Golden Gate Fields on 2/03/23 and finished 5th. The trainer of record is Eoin G. Harty. Trainer Harty invoked the right to split-sample testing, which was submitted to Texas Veterinary Medical Diagnostic Laboratory. Investigation revealed that El Joy was provided phenylbutazone that was prescribed to another horse. On 3/21/23, the TVML analysis report confirmed the presence of Phenylbutazone for Test Sample #GG41231.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
