

COMPLAINT

CASE NUMBER: **23GG0054**

The CHRB hereby files a complaint against **Eoin G. Harty** for violation of HISA Rule **2262(c)(5)**. The person named in this complaint holds a license as a **Trainer/Owner & Stable (Equilete Inc.)**, license number **066943 - 11/25, 328176 - 11/23 & (stable) 600410 - 12/25**. The offense alleged occurred on or about **2/03/23** and is as follows:

The horse El Joy, Trained by Eoin G. Harty, ran in race #4 at Golden Gate Fields, finishing 5th. El Joy was claimed in that race by Trainer Timothy Bellasis (070354 -10/23) and owners Cassandra Tschanz (079792-1/24) and Donna Smartt (113959-9/23) for \$20,000. On 2/21/23, CHRB Investigators were informed that the blood sample taken immediately after the race from El Joy tested positive for phenylbutazone (Case# 23GG0020). Trainer Harty invoked the right to a split sample. On 3/24/23, Texas Veterinarian Medical Diagnostic Laboratory confirmed the presence of phenylbutazone. Ruling PRTG057 on 05/05/23 imposed a fine. According to Horseracing Integrity and Safety Authority (HISA) Rule 2262(c)(5), the horse's claim shall be voided and the horse and claim money returned.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
