

## COMPLAINT

CASE NUMBER: **12DM0015**

The CHRB hereby files a complaint against **CARLA GAINES** for violation of CHRB Rule **1843(a,b,&d), 1844(b), 1844(e)(14), 1887, 1859.5**. The person named in this complaint holds a license as a **TRAINER**, license number **101504**. The offense alleged occurred on or about **JULY 14, 2012** and is as follows:

**The official urine sample HP10517 taken on July 14, 2012, at Betfair Hollywood Park was reported by Scott Stanley of U.C. Davis Laboratories to contain testosterone in urine (390ng/ml) in excess of the regulatory urine threshold permitted for testosterone in fillies and mares of 55ng per milliliter. This sample was obtained from the horse A Little Luckier which ran in the 1<sup>st</sup> race at Betfair Hollywood Park finishing 2<sup>nd</sup>. The trainer of record is Carla Gaines. The split sample sent to the University of Florida confirmed the testosterone level to be in excess of the urine regulatory threshold.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
