

COMPLAINT

CASE NUMBER: **20BM0010**

The CHRB hereby files a complaint against **Jamey Ray Thomas** for violation of CHRB Rule **1843(a),(b)&(d), 1843.1(a), 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **243598-02/21**. The offense alleged occurred on or about **7/10/2020** and is as follows:

The official blood and urine samples # F17919 taken on July, 10, 2020 at Golden Gate Fields was reported by Dr. Ben Moeller, PhD of the Maddy EACL at U.C. Davis to contain Gabapentin in the blood (2.0 ng/mL) and in the urine (100.0 ng/mL). The samples were obtained from the horse "COZZE KID which ran in the 6th race on July 10, 2020 finishing 3rd. The trainer of record is Jamey R. Thomas. A split sample analysis was requested, and the presence of Gabapentin was confirmed by Texas Veterinary Medical Diagnostic Laboratory. Gabapentin is a prohibited Class 3, Penalty B violation.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
