

# COMPLAINT

The CHRB hereby files a complaint against **Dan L. Markle** for violation of CHRB Rule **1843(a),(b)&(d), 1843.1.(b), 1844(d)(2), 1866(e), 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **223583 Exp. 7/2022**. The offense alleged occurred on or about **01/09/2021** and is as follows:

**The official blood sample # NC33963 taken on 1/09/2021 at Golden Gate Fields was reported by Dr. Ben Moeller, PhD of the Maddy EACL at U.C. Davis Laboratories, to contain Hydroxydantrolne (15.6 ng/mL). The sample was obtained from the horse "Real Trouble" which worked for removal from the Veterinarian's List. The trainer of record is Dan L. Markle. No split sample request was made. Dantrolene is a Prohibited Drug Class 4, Penalty Class C violation.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
