

# COMPLAINT

CASE NUMBER: 21LA0056

The CHRB hereby files a complaint against **Adan Farias** for violation of CHRB Rule **1588(a)(14), 1843(a,b&d), 1843.1(b), 1866(e&f), & 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **268424 - 11/2023**. The offense alleged occurred on or about **4/3/2021** and is as follows:

**Official work blood sample #NC50154 taken on 4/3/2021 at LARC from the horse, "BDR Exclusive" was reported by Ben Moeller, PhD of the Maddy EACL at UC Davis contained Dexamethasone (228pg/mL). The horse, "BDR Exclusive" worked on 4/3/2021 under Veterinarian Listed Requirements in order to be eligible to race. The split analysis was not requested in accordance to 1859.25. Adan Farias is the trainer of record. Dexamethasone is a class 4 prohibited drug substance with a penalty class C.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
