

# COMPLAINT

CASE NUMBER: 21SA0066

The CHRB hereby files a complaint against **DOUG O'NEILL** for violation of CHRB Rule **1843(a)(b) &(d), 1843.1(a), 1843.4, 1844(d)(5) and 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **112723-05/2023**. The offense alleged occurred on or about **May 30, 2021** and is as follows:

**The official blood sample #SA34170 taken on May 30, 2021, was reported by Ben Moeller, Ph.D., of the Ken Maddy Equine Analytical Chemistry Laboratory (EACL) at U.C. Davis to contain Methocarbamol. The sample was obtained from the horse "Deise Delight" who ran in the 7th race at Santa Anita and finished 2<sup>nd</sup>. The trainer of record is Doug O'Neill (112723-05/2023). Per CHRB Rule 1859.2, O'Neill requested that a split sample be tested. On July 23, 2021, the lab confirmed the original finding of the substance Methocarbamol as reported by the CHRB's official laboratory. Methocarbamol is a Class 4 drug with a Penalty Category C.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
