Ruling # 8

JOCKEY CRUZ MENDEZ IS FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (b)(8) (USE OF RIDING CROP –MORE THAN SIX TIMES DURING THE RUNNING OF THE RACE) WHILE RIDING IN THE TENTH RACE AT LOS ALAMITOS RACE COURSE ON JANUARY 2, 2022.

(5) OBJECTION/ INQUIRY

In the 2nd race, the trainer of #3 She's Not To Blame (trainer CC Perkinson) lodged an objection against the #4 horse BlackJack Betty for interference near the ¼ pole. After review, the stewards determined there was no violation.

(6) INCIDENTS

An incorrect ownership was programmed for 2nd race #3 She's Not To Blame (trainer CC Perkinson) and was corrected to CC Perkinson Racing.

In the 6th race about 25 yards out of the gate, #6 Big Fabuloso locked up behind and fell on the track. He was vanned off.
