RULING #01

In the Matter of: Driver Jesse Pacheco

Ruling #01

Driver Jesse Pacheco, who drove #6 MIKI'S MAGIC RIDE in the first race on Friday, December 17, 2021, is hereby fined the sum of one hundred dollars (\$100.00) for violating California Horse Racing Board Rule #1721 (I) (commit any act which shall impede the progress of another horse). While driving MIKI'S MAGIC RIDE, Mr. Pacheco did change course during third quarter where clearance did not exist, impeding the progress of #7 DISCLOCATOR, driven by Lemoyne Svendsen, by hooking wheels and causing the horse to lose momentum. MIKI'S MAGIC RIDE finished 3rd and was placed 4th for the violation.

In the Matter of: Driver Michael Campbell

Ruling # 02

Driver Michael Campbell, who drove #3 DOMINATE DRAGON in the third race on Friday, December 17, 2021, is fined the sum of one hundred dollars (\$100.00)* for violation of California Horse Racing Board Whipping Rule #1734 (b) (Whipping shall be restricted to elbow and wrist action only). First offense in sixty (60) days.

RULING #03

In the Matter of: Driver James Kennedy

Ruling # 03

Driver James Kennedy, who drove #2 LICKCREEK SPEEDWAY in the ninth race on Friday, December 17, 2021, is hereby fined the sum of one hundred dollars (\$100.00)* for violation of California Horse Racing Board Rule #1721 (I) (Commit any act which shall impede the progress of another horse). While driving LICKCREEK SPEEDWAY, Mr. Kennedy did change course during the stretch drive where clearance did not exist, impeding the progress of #8 GO AWAY N PLAY, driven by Mel Mullet, forcing him wide and to lose momentum. LICKCREEK SPEEDWAY finished 2nd and was placed 3rd for the violation.

6th Race- #7 SHES A LIVE WIRE, appeared to strike the wheel of #5 HURRY HOME and made a nasty break in stride. Driver Gerald Longo pulled the horse up during the second quarter. Dr. Eduardo De La Cruz examined and treated the horse with Flunixin. SHES ALIVE WIRE was vanned off by the horse ambulance and returned to her stall.
