RULINGS WRITTEN

The following rulings were written:

Ruling # 05

Trainer Jessie Pacheco, the trainer of record of #2 I'M AN ATHLETE programmed to race in the 1st race on Sunday, January 2, 2022 at Cal Expo is hereby fined the sum of fifty dollars (\$50.00) for violation of the California Horse Racing Board rule #1894 (Duties of trainer-Late Driver Change).

Ruling # 06

Driver Luke Plano is hereby fined the sum of Fifty Dollars (\$50.00)* for violation of California Horse Racing Board Rule #1721 (i). While driving #3 HE GRINS AGAIN in the first race on January 2, 2022, at Cal Expo Harness, Mr. Plano did fail to set and maintain a reasonable pace (slow second quarter 31.2). First Offense in 60 days.

Ruling # 07

Driver Luke Plano is hereby fined the sum of fifty Dollars (\$50.00)* for violation of California Horse Racing Board Rule #1721 (i). While being the listed driver on #1 ALWAYS GLAD in the fifth race on Sunday, January 2, 2022 at Cal Expo Harness, Mr. Plano did fail to post parade the horse in a timely fashion (seven minutes late).

Ruling # 08

Driver Jessie Pacheco, who drove #8 URKILLINMESMALLS in the fifth race on Sunday, January 9, 2022 is hereby fined the sum of two hundred Dollars (\$200.00)* for violation of California Horse Racing Board Whipping Rule #1734 (b) (Whipping shall be restricted to elbow and wrist action only).
Second offense in 60 days.

Ruling # 09

Trainer Quentin Schneider, the trainer of #3 OFFICER JIM in the third race on Sunday, January 9, 2022 is hereby fined the sum of Fifty Dollars (\$50.00)* for violation of California Horse Racing Board Rule #1894 (Duties of trainer-Late Driver Change).

Ruling # 10

Trainer Jose Castillo, the trainer of record of #4 DEVILS BROTHER programmed to race in the fifth race on Sunday, January 9, 2022 at Cal Expo Harness is hereby fined the sum of Fifty dollars (\$50.00)* for violation of California Horse Racing Board rule #1894 (Duties of a trainer-Late Driver Change).

1st Race – Trainer/Driver Jessie Pacheco was informed that he was being fined fifty dollars (\$50.00) for violation of California Horse Racing Board rule #1894- Duties of the Trainer (being late to the post parade with #5 FUTURE DELIGHT).

4th Race Late Declaration- #1 BOASTER COASTER-Trainer Jenna Cornelison. The driver and trainer were unable to get the horse on the track. #1 BOASTER COASTER was put on the Stewards' List as unmanageable and must qualify twice. A refund was issued of two thousand one hundred twenty-six dollars and forty-eight cents (\$2,126.48).

5th Race-Stewards List- #5 BEACH BUM BOB-Trainer Nick Roland was put on the stewards' List for a Break off Qualifier.
