A formal hearing was held in the Stewards' Office at 11:00 AM at Cal Expo regarding California Horse Racing Board Complaint # 21SW0019. The complaint alleges violations of California Horse Racing Board Rules #1840 (Veterinary Practices and Treatments Restricted (Injecting Horses) 2 counts, #1843 (c) (Medications, Drugs and Other Substances), (Possession of Injectable Medications) 1 count, California Horse Racing Board Rule #1890 (a), (Medications, Drugs and Other Substances), (Possession of Injectable Medications) 1 count, California Horse Racing Board Rule #1890 (b), (Possession of Contraband – Injectable Medications) 1 count, California Horse Racing Board Rule #1489 (4), (Grounds for Denial or Refusal of License, (License Required to inject horses) 2 counts, California Horse Racing Board Rule #1989 (7), (Grounds for Denial or Refusal of License), (Moral Turpitude), California Horse Racing Board Rule #1900, (Grounds for Suspension or Revocation), California Horse Racing Board Rule #1902, (Conduct Detrimental to Horse Racing) against Trainer, Jessie Pacheco. California Horse Racing Board Supervising Special Investigator Louis Quezada, Court Reporter Wendy Frazier and all Stewards were present.

RULING #13

In the matter of Driver Gerald Longo:

Driver Gerald Longo who drove #5 MIKI'S MAGIC RIDE in the tenth (10th) race on Sunday, January 23rd, 2022, at Cal Expo, is hereby fined the sum of one-hundred dollars (\$100.00)* for violation of California Horse Racing Board rule #1894 (Failure to drive when programmed).

RULING #14

In the matter of Trainer Jessie Pacheco:

After a formal hearing was conducted in the Cal Expo Stewards Office January 27, 2022, Trainer Jessie Pacheco is hereby issued a full suspension for a period of 365 days (02/02/2022 thru 01/31/2023) and fined five thousand dollars (\$5,000.00) for a violation of California Horse Racing Board Rule #1840 (Veterinary Practices and Treatments Restricted), California Horse Racing Board #1843 (c) (Medications, Drugs and other substances), California Horse Racing Board Rule #1890 (a & b) (possession of Contraband), California Horse Racing Board Rule #1902 (Conduct detrimental to horse racing), California Horse Racing Board Rule #1489 (4 & 7) and California Horse Racing Board Rule #1900 during inspection of Mr. Pacheco's barn on November 10th, 2021, California Horse Racing Board Investigators Bartholomew and Quezada found hypodermic needles and syringes along with an injectable medication bottle with the label removed. During the term of this suspension, all licenses' privileges of Mr. Pacheco are suspended and pursuant to California Horse Racing Board Rule #1528. Subject is denied access to all premises in this jurisdiction. All horses trained by Mr. Pacheco are suspended and may only be transferred with permission from the Stewards at Cal Expo or Executive Director of the California Horse Racing Board.
