Report of the Board of Stewards for the week of April 4, 2022, through April 10, 2022.

Monday

04/04/2022

(1) DUTY STEWARD

Richard Williams shall be present for the morning chores for the week and shall commit the minutes to this report.

(2) HEARING

A hearing was held on C.H.R.B. complaint #22LA0038 against Trainer Amador Sanchez for violation of C.H.R.B. rule 1876 filed by Post Time Self Insurance Group for the amount of \$1,000.00. Mr. Sanchez failed to appear. Mr. Sanchez is currently racing at Gulfstream Park. A phone call was made to Mr. Sanchez and there was no answer. The Senior State Steward in Florida was contacted and asked to relay a message to Mr. Sanchez that he had failed to appear and would be suspended. Before the close of business, Mr. Sanchez contacted Post Time Self Insurance and paid the obligation.

Ruling #48

JOCKEY ARMANDO CERVANTES IS FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (b)(7) (USE OF RIDING CROP – MORE THAN TWO TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND) WHILE RIDING IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON APRIL 3, 2022.

(5) **OBJECTION/ INQUIRY**

In the 10th race, the inquiry sign was posted for an incident involving #5 Misty Favorite (Jockey Henry Reynoso Lopez) leaving the gate. The #5 Misty Favorite broke out into the #7 horse Go West Young Man then veered in catching the heels of the #4 horse Bet Thru The Eagle unseating Mr. Lopez. The Stewards determined that the #5 Misty Favorite and Mr. Lopez caused all of their own problems.

(6) **INCIDENTS**

In the 1st race, Jockey Ricardo Ramirez had over scheduled himself by riding in a late race at Santa Anita, making him too late to fulfill his obligation in the 1st race here. Mr. Ramirez was replaced by Erick Garcia who subsequently won the race.

In the 10th race, #5 Misty Favorite (Jockey Henry Reynoso Lopez) veered in and clipped heels of the #4 horse Bet Thru The Eagle shortly after the break and unseating the rider of the #5 Henry Reynoso Lopez. The horse Misty Favorite and Jockey Henry Reynoso Lopez were uninjured.

Ruling # 51

JOCKEY ARMANDO VIRAMONTES IS FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (USE OF RIDING CROP) (b)(8) (MORE THAN SIX TIMES DURING THE RUNNING OF THE RACE) WHILE RIDING IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON APRIL 9, 2022.
