The following rulings were written

Ruling #32

Driver Michael Campbell who drove #5 CASA MIASA in the 2nd race on Friday, April 8, 2022, is hereby fined the sum of one-hundred dollars (\$100.00)* for violation of California Horse Racing Board Whipping Rule #1734 (d) (Driver may not use the whip more than three times in succession without giving the horse a chance to respond). First offense in sixty (60) days.

Ruling # 33

Driver Cordarius Stewart, who drove #6 SHES A SHOWSTOPPER in the 1st race on Friday, April 8, 2022, is hereby fined the sum of one hundred dollars (\$100.00) for violating California Horse Racing Board Rule #1721 (b) (Jostle, strike, hook wheels, or interfere with another horse or driver). While driving #6 SHES A SHOWSTOPPER during the third quarter, Mr. Stewart did strike the wheel of #3 DELIGHTFULLY WILD and flattening the tire on the race bike.
