Report of the Board of Stewards for the week of June 6, 2022, through June 12, 2022.

Monday

06/06/2022

(1) DUTY STEWARD

Richard Williams is in the office for the morning entries, scratches and panel meetings.

(2) HEARINGS

Two hearings were scheduled for Monday, June 6th.

A hearing was scheduled for a complaint filed against Rafael Sanchez by the California Horse Racing Board for violation of rule #1876 (Financial Responsibility). Mr. Sanchez failed to appear and a ruling will be issued.

A hearing was scheduled for a complaint filed by the California Horse Racing Board against Tirso Rivera for violation of rule #1876 (Financial Responsibility). At the time of the scheduled hearing, a representative of Post Time Self Insurance appeared and informed the stewards that he had just spoke with Mr. Rivera and the matter had been resolved.

(1) CAL-BRED REPORT

The first race in the book, for California Bred Maidens two year olds going 300 yards, was used open as two races of 6 horses each.

(1) **CAL-BRED REPORT**

(4) **RULINGS**

Ruling #73

OWNER RAFAEL SANCHEZ, HAVING FAILED TO RESPOND TO CHARGES ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY- \$1,269.00 TO KC HORSE TRANSPORTATION), IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR). THE SUSPENSION WILL TAKE EFFECT ON JUNE 13, 2022.

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF RAFAEL SANCHEZ, ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), RAFAEL SANCHEZ IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Ruling # 74

JOCKEY EDGAR PAYERAS IS SUSPENDED FOR THREE (3) RACING DAYS (JUNE 18TH, 19TH, AND 25TH, 2022) FOR ALTERING COURSE WITHOUT SUFFICIENT CLEARANCE, CAUSING INTERFERENCE WHICH RESULTED IN THE DISQUALIFICATION OF HIS MOUNT FROM SECOND TO SIXTH POSITION WHILE RIDING BLAMELESS IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON JUNE 5, 2022. THIS CONSTITUTES A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES-CARELESS RIDING).

(5) OBJECTION/ INQUIRY

Following the 5th race, the Stewards posted the inquiry for an incident involving #1 Chester Carlson (trainer Scott Willoughby) (jockey Jonathan Roman) and #2 Teller Opener MRL (trainer Jose Flores) (jockey Erasmo Gasca). In approximately the last 150 yards, #1 Chester Carlson bore out and interfered with #2 Teller Opener MRL causing interference. #1 Chester Carlson finished 1st and was placed 2nd, #2 Teller Opener MRL finished 2nd and was placed 1st.

The Stewards posted the inquiry sign for the 7th race, #3 The Kids A Cowboy (trainer James Glenn, Jr.) (jockey Juan Pablo Leon) broke to the outside sharply and # 7 Coronas Invader (trainer Felix Gonzalez) (jockey Henry Reynoso Lopez) broke sharply to the inside with both horses causing interference with the #4 An Odd Sort (trainer Jesus Nunez) (jockey Jairo Rangel), #5 Griffindore (trainer Paul Jones) (jockey Ruben Lozano) and #6 How High (trainer Scott Willoughby) (jockey Jonathan Roman). #3 The Kids A Cowboy finished 2nd and was placed 8th and then placed 7th. #7 Coronas Invader finished 6th and was placed 5th then was placed 8th.

(6) HEARINGS

Jockey Edgar Payeras was in the office to address an incident in the 6th race on 6/05/2022 involving interference that resulted in the disqualification of his mount. A decision will be issued after deliberation.

JOCKEY JUAN PABLO LEON IS SUSPENDED FOR THREE (3) RACING DAYS (JUNE 19TH, 25TH, AND 26TH, 2022) FOR FAILURE TO MAKE A PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE AT THE START, CAUSING INTERFERENCE WHICH RESULTED IN THE DISQUALIFICATION OF HIS MOUNT FROM SECOND TO SEVENTH POSITION WHILE RIDING THE KIDS A COWBOY IN THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON JUNE 11, 2022. THIS CONSTITUTES A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES- CARELESS RIDING).

Ruling # 76

JOCKEY JUAN PABLO LEON IS FINED SEVEN HUNDRED FIFTY DOLLARS (\$750.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (b)(7) (USE OF RIDING CROP – MORE THAN TWO TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND) RIDING IN THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON JUNE 11, 2022.

(5) OBJECTION/ INQUIRY

(6) INCIDENTS

Prior to the 5th race, horse ID informed the Stewards that the #1 horse in the 6th race was a gelding but was programmed as a colt. The Stewards scratched the horse as ineligible and an investigation was initiated to determine the events that led to the error.

In the 8th race, jockey Armando Cervantes informed the Stewards he was feeling ill. The Stewards relieved him of his duties.
