Steward Calvin Rainey again joined the Panel to review Saturday's entries. The Racing Office was able to put together nine races for Sunday's closing day.

**FRIDAY**7/29/22<sup>1</sup>**ROMAN RULING****RULING #6**

Having violated the Horse Racing Integrity and Safety Act (HISA) Rule #2280 (Use of Riding Crop) and pursuant to HISA rule #2282 (Riding Crop Violations and Penalties – Class 3) Jockey **EVIN ROMAN** who rode **TIZ AN EDVENTURE** in the seventh (7<sup>th</sup>) race at the California State Fair (Cal Expo) on Sunday, July 24,

2022 is suspended one (1) racing day, Friday, August 5, 2022, and fine TWO HUNDRED and FIFTY DOLLARS (\$250.00)\* for one strike over the limit.

Furthermore, Jockey **EVIN ROMAN** is assigned three (3) points that will expire on January 29, 2022, six months from the date of final adjudication pursuant to HISA Rule #2282 (Riding Crop Violations and Penalties).

The above ruling was issued after Mr. Roman appeared and reviewed the race with the Stewards. Mr. Roman hadn't realized until seeing the video that he had used the riding crop seven times. Mr. Roman accepted the penalty which is his second in the last month. He was cautioned that if he continues to violate the riding crop rule that the penalties will start increasing.

After review it was determined that #4 PLAISIR lugged in and instigated the contact between the two runners and the photo finish showed the #2 STAN THE HAT MAN winning by a nose. Since the #2 STAN THE HAT MAN beat the #4 PLAISIR no change was necessary.

A tape-recorded hearing was convened today to hear two complaints over incidents at the Alameda County Fair Grounds concerning licensees Gary “Guy” Greiner and Natalie Jennings.

The cases were identical, and both were charged with alleged violation of California Horse Board (CHRB) Rule #1874 Disorderly Conduct.

Ms. Jennings contended that Mr. Greiner tried to push her pony and almost knocked her off her mount.

Mr. Greiner contended that Ms. Jennings tried to run him over with her pony. After the incident both were yelling at each other, and Investigator Louis Quezada attempted to calm Mr. Greiner who had gone to the Investigator’s Office. Decision to follow.

### SAC Ruling #7

Pony Rider **NATALIE A. JENNINGS** is fined ONE HUNDRED DOLLARS (100.00)\* for participating in a boisterous altercation in the Stable Area on June 22, 2022, at the Alameda County Fairgrounds; a violation of California Horse Racing Board Rule #1874 (Disorderly Conduct).

### SAC RULING #8

Association Employee **GARY "GUY" GREINER** is fined ONE HUNDRED DOLLARS (\$100.00)\* for participating in a boisterous altercation in the Stable Area on June 22, 2022, at the Alameda County Fair, a violation of California Horse Racing Board Rule #1874 (Disorderly Conduct).

The above rulings were issued after deliberation over yesterday's hearings. This Board of Stewards felt that both parties were at fault.

### 1<sup>ST</sup> RACE OBJECTION – NO CHANGE

Jockey Pablo Flores, aboard second (2<sup>nd</sup>) place finisher #3 THREE TIMES A LADY lodged a claim of foul against first (1<sup>st</sup>) place finisher #2 APPROVAL GIVEN and Jockey Epifanio Garcia in this three hundred (300) yard Quarter horse event. After review, no change was made. Both horses bore out slightly the last one hundred (100) yards. No contact or interference was detected. The decision was unanimous.
