GOODGAME RULING

HCFA Ruling #06

Having violated the Horse Racing Integrity and Safety Act (HISA) Rule #2280 (Use of Riding Crop) and pursuant to HISA rule #2282 (Riding Crop Violations and Penalties – Class 3) Jockey RACHEL GOODGAME who rode STRIKE IT LUCKY in the seventh (7th) race at the Humboldt County Fair on Saturday, August 27, 2022, is suspended one (1) racing day, September 4, 2022, and fined Two Hundred and Fifty Dollars (\$250.00) for three (3) strikes over the limit.

Furthermore, Jockey RACHEL GOODGAME is assigned three (3) points that will expire on February 28, 2023, six months from the date of final adjudication pursuant to HISA Rule #2282 (Riding Crop Violations and Penalties).

The above ruling was published after Jockey Rachel Goodgame admitted misuse of the riding crop in her excitement to be victorious. Video verified that the penalty was justified.
