08/30/2022

A hearing was held for California Horse Racing Board complaint #22LA0095 against Tyler Hart for violation of California Horse Racing Board Rule #1874 (Disorderly Conduct). Present were Chief Investigator Kevin Kitashima, court reporter Michelle Derieg, licensee Tyler Hart (by phone), Stewards Tom Ward, James Dreyer and me, Richard Williams. California Horse Racing Board Chief Investigator Kevin Kitashima presented the case for the board. Statements were read into the record from witnesses to the incident. During his testimony, Tyler Hart admitted to the conduct and said he was responsible for his actions. He further stated that he was prepared to accept our decision and asked us to consider that he had already had consequences for his actions that have impacted him financially and professionally. A decision will be reached by the stewards.
