10/27/22²**BERNARD HEARING**

The Board of Stewards heard case # 22SR0037, filed against trainer LISA BERNARD, sighting two possible CHRB rule violations (#1878; Workouts and #1482; Employment of Unlicensed Person). Present in the hearing were Stewards Kim Sawyer, Luis Jauregui, and Dave Nuesch (filling in for Rich Williams), with investigator Ryan Russell presenting the case. Additionally, trainer Lisa Bernard was accompanied by her "Service K-9" and represented by her attorney Suzanne Porrazzo. Trainer Bernard agreed to the no veterinary exam prior to workout violation but stated that she had no reason to believe that her farrier was not possessing the proper license. The Stewards will deliberate the facts of the case and should reach a decision in the coming days. More to follow...

10/27/22³**RIVERA HEARING VIA MICROSOFT TEAMS**

The Stewards also heard a possible crop violation from San Luis Rey Downs Training Center. The security citation was issued to exercise rider YAEL RIVERA, at the request of Safety Steward George Yniguez. Also listed on the citation were two witnesses, monitoring veterinarian Dr. Pirrone and outrider Linda Baze. Mr. Rivera was present in the CHRB office at

SLRD, along with George Yniguez and SLRD employee Laura Cruise, translating for Mr. Rivera. The Stewards felt that Mr. Rivera's actions were excessive and beyond what was necessary for the safety of the horse or rider. Ruling to follow.

The nine-race card went with only one major issue. After leaving the gate for the 5th race the #6 TOFINO BAY (jockey Edwin Maldonado) had the left rein come loose. Edwin Maldonado remained cool and made the best of a bad situation, stayed out of trouble, and saved any catastrophe. There was a Stewards review into the incident and found no reason for an inquiry.
