Report for Monday, October 31, 2022, Through Sunday, November 6, 2022.**WEDNESDAY**11/2/22¹**ENTRY STEWARD**

Rich Williams was available to oversee entries for Saturday (ten races) and approve changes for Friday's program (ten races).

THURSDAY11/3/22¹**ENTRY STEWARD**

Again, Steward Williams was present to adjudicate any matters concerning entries for Sunday (ten races) and scratches for Saturday's program.

11/3/22²**BROCKLEBANK HEARING CASE 17SA0234 ref 11-25-17³ and CASE 21SA0076 ref 07-31-21³**

The hearing was scheduled by the CHRB as MR. BROCKLEBANK was suspended for failure to appear. This hearing gave him the opportunity to appear and produce documentation proving his status pertaining to the Writ of Execution issued in 2017 stating, he, Mr. Brocklebank owed owner Barbara Black one hundred ninety-two thousand four hundred eighty-four dollars and eight seven cents (\$192,484.87). Mr. Brocklebank previously failed to appear for the CHRB hearing in 2017 and a ruling was issued on November 25, 2017, suspending him for such, (DFTD #033) ref 11-25-17³. In 2021 Mr. Brocklebank's trainer's license was erroneously renewed by the CHRB in Sacramento. Upon this discovery, another ruling, (DMTD #27) ref 03-31-21³ was issued on 08-01-22, post scheduled hearing, his license was again suspended for failure to appear.

Present for the hearing today were CHRB Investigator Mike Barker (Microsoft Teams), attorney for owner Barbara Black, Ms. Rachel Kosmal McCart (Microsoft Teams) and respondent John

Brocklebank (in person). Both parties provided documentation stating their opinions on the status of the Chapter 13 filed by Mr. Brocklebank. Decision to follow.

WOZNY CITATION HEARING

A Microsoft Teams hearing was formulated by CHRB Investigator Ryan Russell who was located at San Luis Rey Training Center along with the respondent. The hearing involved three citations that were issued to MS. WOZNY. The first was for smoking in the shed row of a barn. The other two involved her dog being off leash and failure to clean up after her dog. A ruling will be issued tomorrow.

LOPEZ CITATION HEARING

The hearing was set through Microsoft Teams from San Luis Rey Training Center (Investigator Russell), was heard when groom GUSTAVO LOPEZ was cited for smoking. He pled guilty and stated he understands smoking is not allowed at the training center. A ruling will be issued.

Exercise Rider DARIA WOZNY is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of California Horse Racing Board Rule #1928 (Fire Regulations - smoking in the barn area) and #1437 (Conditions of a Race Meeting - dog off the leash) which occurred at San Luis Rey Training Center on September 24, 25, and 26, 2022.

LOPEZ RULING LATC #24

Groom GUSTAVO LOPEZ is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board Rule #1928 (Fire Regulations- smoking in the barn area) which occurred at San Luis Rey Training Center on October 15, 2022.

MIYADI RULING LATC #25

Trainer STEVE MIYADI is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board Rule #1437 (Conditions of a Race Meeting - dog off the leash) which occurred at Santa Anita Park on October 29, 2022.

After two telephonic hearings were held, both respondents pled guilty. Their penalties are listed in the following rulings.

LATC RULING #27

Jockey EDUARD ROJAS FERNANDEZ is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1688(b)(1) (Use of Riding Crop - use of crop during a.m. training) on November 5, 2022, at Santa Anita Park.

LATC RULING #28

Jockey JUAN LOPEZ is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1688(b)(1) (Use of Riding Crop - use of crop during a.m. training) on November 5, 2022, at Santa Anita Park.

JOCKEY FILM REVIEW

KYLE FREY met with the Stewards to review his ride in the first race. The video showed Mr. Frey leaning inward more than necessary on the outside of a four-horse spread approaching the 3/8 marker. Warning.

Apprentice ARMANDO AGUILAR met with the Stewards to review the use of his crop in the sixth race on Friday. After a review of the video, he acknowledged his mistake. His penalty is listed in the following ruling.

LATC RULING # 29

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (c)(5) & (6) (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3), Apprentice Jockey ARMANDO AGUILAR, who rode MONGOLIAN NINJA in the sixth race at Santa Anita Park on November 4, 2022, is suspended for one (1) day November 13, 2022), and fined TWO HUNDRED AND FIFTY (\$250.00)* for over use of the riding crop after reaching its maximum placing.

Furthermore, Apprentice Jockey ARMANDO AGUILAR is assigned three (3) violation points that will be expunged on May 6, 2023, six (6) months from the date of final adjudication pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties. Apprentice Jockey ARMANDO AGUILAR has accrued a total of three (3) points.

Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

INQUIRY / NON-STARTER /THIRD RACE ¾ dirt

Following the running of the race the inquiry sign was posted to review the start that involved #6 SENOR JOBIM (U. Rispoli 6th). After a review of the available videos and conversation with Starter Jay Slender in a unanimous decision #6 SENOR JOBIM did not receive a fair start through no fault of the horse. Therefore, #6 SENOR JOBIM was declared a non-starter per CHRB rule 1696 (b) (The Start).
