OCAMPO RULING

The following ruling was issued after an informal hearing was held via telephone. Mr. Ocampo acknowledged his mistake and accepted the penalty.

DFTD RULING #06

Exercise rider ISRAEL OCAMPO is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1688 (b)(1) (Use of Riding Crop – use of crop during a.m. training) on November 11, 2022, at Santa Anita Park.

INQUIRY /NO CHANGE /SECOND RACE one mile dirt

Following the running of the race the inquiry sign was posted to review the start that involved #6 Divinely Bolt (R. Vasquez DNF). Leaving the starting gate #6 broke hard and went to its knees and unseated the jockey. In a unanimous decision the horse stumbled to no fault of outside sources and the race was made official.

INQUIRY /NO CHANGE /THIRD RACE one mile turf

Following the running of the race the inquiry sign was posted to review an incident in mid-stretch that involved #3 Mitad Del Mundo (U. Rispoli 4th), #6 Mastermind (A. Alsagoor 5th) and #7 Naismith (J. Hernandez 1st). #6 drifted out and made contact with #7 who shifted into #3. As both #3 and #7 out finished #6 the issue was moot, and the original order of finish was made official.

INQUIRY /DISQUALIFICATION /FIFTH RACE one mile turf

Following the running of the race the inquiry sign was posted to review an incident in mid-stretch. Involved were #1 Carmen Miranda (F. Prat 2nd) and #11 Sunshine Babe (H. Berrios 1st). After conversation with the Patrol Judge and both jockeys in a unanimous decision #11 was disqualified from first and placed second behind #1 as #11 drifted outward making contact with #1 costing that one a better placing.

JOCKEY FILM REVIEW

Apprentice Abdul Alsagoor met with the Stewards to review his ride in the third race yesterday that pertained to an inquiry in the stretch run (ref 11-25-22³). Mr. Alsagoor was issued the following ruling for his lack of effort to correct the drift.

DFTD RULING #07

Apprentice Jockey ABDIL ALSAGOOOR, who rode MASTERMIND in the third race at Del mar Race Track on Friday, November 25, 2022, is suspended for THREE (3) racing days (December 3, 4 and 9, 2022) for failure to maintain a straight course in the stretch and causing interference. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – Careless Riding).

Hector Berrios met with the Stewards to review his ride in the fifth race yesterday that involved an inquiry and a disqualification of his mount (ref-11-25-22⁴). Mr. Berrios was very candid stating he made a mistake, and his penalty is listed in the following ruling.

DFTD RULING #08

Jockey HECTOR BERRIOS, who rode SUNSHINE BABE in the fifth race at Del Mar Race Track on November 25, 2022, is suspended for three (3) racing days (December 3, 4 and 9, 2022) for failure to make the proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of his mount from first to second place. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – Careless Riding)

Flavien Prat met with the Stewards to review his ride in the seventh race yesterday. This involved his inward drift soon after the start that affected two horses to his inside. Mr. Prat left the office with a warning and direction to correct this style of riding in the future.
