Three hearings and one citation were scheduled for Thursday morning.

A hearing was scheduled for complaint 23SA0050 filed against GREAT AMERICAN RACING for violation of California Horse Racing Board rule #1876 Financial Responsibility \$2,220.00 owed to KC Horse Transport. KC Horse Transport contacted the California Horse Racing Board Investigators and informed them that the amount owed of \$2,220.00 had been paid and requested that the complaint be withdrawn. The complaint was withdrawn.

A hearing was scheduled for complaint 23SA0052 filed against Owner ROBERT HENIE for violation of California Horse Racing Board rule #1876-Financial Responsibility \$1,408.00 owed to KC Horse Transport. KC Horse Transport contacted the California Horse Racing Board

Investigators and informed them that the amount owed of \$1,408.00 had been paid and requested that the complaint be withdrawn. The complaint was withdrawn.

A hearing was scheduled for ATREIDES RACING LLC/TIM MILLER for violation of California Horse Racing Board rule #1876 Financial Responsibility \$2,084.55 owed to KC Horse Transport. Atreides Racing LLC/Tim Miller nor any representative appeared for the hearing. A ruling will be issued.

**LATS Ruling #61**

Owner TIMOTHY R. MILLER (DBA: ATREIDES RACING, LLC), having failed to respond to written notice to appear before the Board of Stewards at Santa Anita Park on May 11, 2023, is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear), pending an appearance at a hearing before the Board of Stewards to answer to charges alleging violation of CHRB rule #1876 (Financial Responsibility \$2,084.55 to KC Horse Transport, Inc.). Suspension to commence May 19, 2023.

During the term of this suspension, all licenses and license privileges of TIMOTHY R. MILLER (DBA: ATREIDES RACING, LLC) are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

**ROLANDO QUINONEZ CITATION**

A Teams meeting was held for ROLANDO QUINONEZ in response to a citation issued for galloping the horse RAGE ON at San Luis Rey Training Center while the track was open for jogging only. Present via Teams were Trainer Rolando Quinonez, and in the Stewards' office at Santa Anita the Board of Stewards Kim Sawyer, Luis Jauregui, and Rich Williams. Upon hearing the facts, the Stewards determined that there were sufficient reasons for Mr. Quinonez to have not known the track was open for joggers only. A warning was given to Mr. Quinonez to be more diligent in checking text messages and announcements in the future.

5/13/23<sup>2</sup>**ABEL CEDILLO RULING**

Jockey ABEL CEDILLO contacted the Stewards by phone and took full responsibility for his use of the crop in the 7<sup>th</sup> race on Friday May 12, 2023. The following ruling was issued.

**LATS RULING #62**

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3), Jockey ABEL CEDILLO, who rode LIBERAL LADY in the seventh race at Santa Anita Park on May 12, 2023, is suspended for one (1) day (May 20, 2023) and fined TWO HUNDRED FIFTY DOLLARS (\$250.00)\* for one (1) strike over the limit.

Furthermore, Jockey ABEL CEDILLO is assigned three (3) violation points that will be expunged on November 13, 2023, six (6) months from the date of final adjudication pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – second offense. Jockey ABEL CEDILLO accrued a total of six (6) points.

Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.
