Trainer GEORGE PAPAPRODROMOU was in our office to answer a complaint filed by the CHRB for rule violations #1868(b)(1), 1843 (d), 1843.1(b), 1843.4, 1842.5 and 1887(a) when his horse "The Slap" contained "Phenylbutazone" in a post workout test sample on February 19, 2023. Mr. Papaprodromou stated the confusion occurred when his employee could have treated the horse and suddenly the barn decided to work the horse. This occurred during the time the track was open one day and closed the next day due to the weather. Decision to follow.

FRESU RULING

As a result of a crop violation by jockey ANTONIA FRESU, in yesterday's first race, the following ruling was issued.

LATS RULING #67

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3), Jockey ANTONIO FRESU, who rode UNJOKABLE in the first race at Santa Anita Park on May 26, 2023, is suspended for one (1) day (June 3, 2023) and fined TWO HUNDRED AND FIFTY DOLLARS (\$250.00)* for one (1) strike over the limit

Furthermore, Jockey ANTONIO FRESU is assigned three (3) violation points that will be expunged on November 27, 2023, six (6) months from the date of final adjudication pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties). Jockey ANTONIO FRESU accrued a total of six (6) points.

Pursuant to California horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

INQUIRY/ DISQUALIFICATION

Following the running of the fifth race, the Stewards posted the inquiry sign to review an incident at the start, where #4 VEGAN (T. Pereira 6th) broke out sharply, into the path of #5 ISLAND LIFE (E. Hernandez 8th). After reviewing the start several times, the Stewards unanimously agreed to disqualify #4 VEGAN from sixth and place him last, behind #5 ISLAND LIFE, the horse he impeded.

BERRIOS RULING

Jockey HECTOR BERRIOS was issued the following ruling after he elected to accept full responsibility when he violated the riding crop rule in yesterday's seventh race.

LATS RULING #68

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3), Jockey HECTOR BERRIOS, who rode FAST BUCK in the seventh race (Daytona Stakes) at Santa Anita Park on May 27, 2023, is suspended for one (1) day (June 4, 2023) and fined FIVE HUNDRED AND EIGHTY FOUR DOLLARS (\$584.00)* for one (1) strike over the limit

Furthermore, Jockey HECTOR BERRIOS is assigned three (3) violation points that will be expunged on November 28, 2023, six (6) months from the date of final adjudication pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties). Jockey HECTOR BERRIOS accrued a total of three (3) points.

Pursuant to California horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.
