JOCKEY FILM REVIEW

Jockeys' Guild Western Regional Manager Darrell Haire representing Ryan Moore joined the Stewards to review the eighth race yesterday wherein Mr. Moore used his crop seven times in the stretch run. Safety Steward David Nuesch observed the hearing. Soon after Mr. Moore was informed of the violation, he telephoned the Stewards upstairs and admitted he overused the crop. Mr. Haire stated, Mr. Moore remarked he over used the crop when the horse's ears went up in the lane. The Stewards could not verify this on the video angles reviewed, therefore they did not agree with this opinion. A safety issue was never mentioned at the hearing. After judging all video angles, in a unanimous decision, the following ruling was issued.

LATC RULING #55

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3), Jockey RYAN MOORE, who rode AUGUSTE RODIN (IRE) in the eighth race at Santa Anita Park on November 4, 2023, is suspended for ONE (1) day (November 12, 2023), and fined

TWENTY THOUSAND AND EIGHT HUNDRED DOLLARS (\$20,800.00)* for one (1) strike over the limit.

Furthermore, Jockey RYAN MOORE is assigned three (3) violation points that will be expunged on May 5, 2024, six (6) months from the date of final adjudication pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties) – first offense. Jockey RYAN MOORE has accrued a total of three (3) points.

Pursuant to California horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

Juan Hernandez representing Irad Ortiz, Jr. met with the Stewards to discuss an incident that occurred in the stretch of the fifth race. Mr. Ortiz told Mr. Hernandez his horse drifted inward when it changed leads and he believed he corrected quickly. The majority concluded, when he crossed over in front of the horse to his inside, that one had to check to avoid the heels of his horse and voted to issue a penalty for careless riding. Steward Jauregui dissented; he believed the incident didn't rise to a careless riding violation.

LATC RULING #56

Jockey IRAD ORTIZ, JR., who rode GOODNIGHT OLIVE in the fifth race at Santa Anita Park on November 4, 2023, is suspended for THREE (3) racing days (November 12, 17 and 18, 2023) for failure to maintain a straight course in the stretch and causing interference; violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

The Stewards posted the inquiry sign following this race. Of particular interest were the actions of original third place finisher #8 GYPSY KING (Ramon Vazquez) and original sixth place finisher #1 HAWKER (Umberto Rispoli).

In mid-stretch #8 GYPSY KING shifted into the path of #1 HAWKER forcing Jockey Rispoli to sharply steady his mount. #1 HAWKER was beaten a 'neck' for fifth place. Stewards Baker and Nuesch voted to disqualify #8 GYPSY KING and place him sixth. Steward Jauregui felt that the path had closed, therefore no change was warranted. Jockey Vazquez was ordered to Film Review with the Stewards at Del Mar on November 10, 2023.
