After a review of the videos, a report from both jockeys and the Patrol Judge, in a unanimous decision, the original order of finish was made official. #6 actually stepped out grazing the hind quarters of #2 causing that one to tip inward.

Following the running of the race the inquiry sign was posted to review an incident entering the stretch. Involved were #1 She's Not Kidding (A. Fresu 2<sup>nd</sup>) and #5 Sand to Sea (R. Gonzalez 3<sup>rd</sup>). #1 veered out from behind another horse to pass, in doing so made contact with #5, pushing that one outward. After conversation with both jockeys, the Patrol Judge and a video review, the original order of finish was made official. In a unanimous decision the incident did not affect the final placing.

Antonio Fresu met with the Stewards to discuss his ride in the sixth race yesterday. The issue being, he stood up for several strides before the wire and when he saw a horse to his outside pass him, he resumed the race riding position at the wire. The margin for a better placing (3<sup>rd</sup>) was a neck. Mr. Fresu stated he believed his horse was very tired. The horse was sent to the test barn to be examined by the Official Veterinarian. It was reported the horse was sound and racing fit. He respectfully accepted the following penalty listed below.

**DFTD RULING #08**

Jockey ANTONIO FRESU, who rode SATIN DOLL in the sixth race at Del Mar Racetrack on November 25, 2023, is suspended for THREE (3) racing days (December 3, 8, & 9, 2023) for violation of California Horse Racing Board rule #1692 (Requirements for Horse, Trainer, and Jockey - failure to ride his mount to the finish, costing him a better finish position).
