3/29/24²**STEWARDS' INQUIRY/NO CHANGE/ACCIDENT**

We posted inquiry sign after the running of the first race (turf) to review the actions of the #7 QUARIA THUNDER (K. Frey) who slipped and the #8 SHE'S A JOKER (S. Gonzalez) who also slipped and fell losing his rider at the quarter pole. After reviewing the video several times, we unanimously voted to make no change to the order of finish. The video shows that the #7 and the #8 both slipped on their own, therefore no change was made. Jockey S. Gonzalez was transported to the nearest hospital to be evaluated. Management chose to move the turf rail from '30' to '0' for the remainder of the turf races.

JUSTIFY RULING

The following ruling was issued after receiving an order from Superior Court of the State of California, County of Los Angeles (case No. 20STCP00144, Ruis Racing LLC vs. California Horse Racing Board) to disqualify Justify the winner from the Santa Anita Derby (G1) the ninth race at Santa Anita Park on April 7, 2018.

LATS RULING #52

The following ruling is issued pursuant to an order from the Superior Court of the State of California, County of Los Angeles (Case No. 20STCP00144, *Ruis Racing LLC vs. California Horse Racing Board*) directing the Board of Stewards to set aside its December 9, 2020, decision and Remand Decision and make a new order disqualifying JUSTIFY and re-distributing the purse pursuant to CHRB Rule No. 1859.5.

Acting on a report from the University of California at Davis, Maddy Laboratory, the official testing laboratory for the California Horse Racing Board, that the urine sample #SA27978, obtained from the horse JUSTIFY, the first-place finisher in the ninth race at Santa Anita Park on April 7, 2018, contained the prohibited substance Scopolamine (CLASS 3). It is ordered that JUSTIFY be disqualified from all purse monies earned and deemed unplaced in accordance with CHRB Rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies earned or awarded to owner(s) CHINA HORSE CLUB INTERNATIONAL LIMITED, HEAD OF PLAINS PARTNERS LLC, STARLIGHT RACING, WINSTAR FARM LLC (\$585,000.00), jockey MIKE SMITH (\$58,450.00) and trainer ROBERT BAFFERT (\$58,450.00) and any trophies associated with the race be returned to the Paymaster of Purses at Santa Anita Park by April 29, 2024, for redistribution pursuant to California Horse Racing Board rule #1760

(Purse Award or Prize to Be Withheld). Failure by any person to comply with an order to return any purse, award or prize erroneously distributed shall be suspended until its return.
