Jockey Armando Viramontes is fined FIVE HUNDRED DOLLARS (\$500.00)* for violation of California Horse Racing Board rule #1688(b)(7)(Use of Riding Crop – more than twice in succession without giving the horse a chance to respond) while riding Favorite Lady Cartel in the ninth race at Los Alamitos Race Course on April 13, 2024.

The above ruling was issued after Jockey Armando Viramontes was guilty of violating Rule #1688.
