Apprentice Jockey WELFIN ORANTES is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to attend film class review on October 18, 2024).

Apprentice Jockey SERAFIN CARMONA was summoned to our office to explain why he missed apprentice jockey film review yesterday morning. Mr. Carmona stated he forgot and promised that it would not happen again. Therefore, he was issued the following ruling.

LATC Ruling #23

Apprentice Jockey SERAFIN CARMONA is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to attend film class review on October 18, 2024).

FILM REVIEW

Apprentice Jockey SERAFIN CARMONA was in this morning to review his ride yesterday's fifth race in which he possibly violated the riding crop rule. After reviewing the video several times, we all agreed that he went one strike over the permitted allowable limit. Mr. Carmona apologized for his actions and accepted the penalty.

LATC Ruling #24

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3 - first offense), Jockey SERAFIN CARMONA, who rode TAISHAN in the fifth race (Purse \$23,000) at Santa Anita Park on October 19, 2024, is suspended for one (1) day (October 27, 2024), and fined TWO HUNDRED AND FIFTY DOLLARS (\$250.00)* for one (1) strike over the limit.

Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.
