WEDNESDAY11/13/24¹**DARK DAY DUTY**

Calvin Rainey was present to assist the Racing Office this week. He oversaw an eight (8) race program drawn for Saturday with fifty (50) runners.

An Entry Panel was on the day's agenda with **Dr. Lorbiecki** directing the group. **Julianna Gomes** and Steward **Rainey** were present for this "Teams" meeting. Sixteen (16) horses were deemed as Hard Watch while two of those were designated to be sent post-race to the Test Barn.

11/13/24²**FATALITY REVIEW**

Dr. Lorbiecki headed a group, **Dr. Franklin, Steward Rainey and Safety Steward Rich**, to discuss issues surrounding a **Felix Rondan** trainee who suffered a fatal injury during training.

THURSDAY11/14/24¹**ENTRY DAY – SCRATCHES - VET PANEL**

Once again, the Board of Stewards were represented by **Calvin Rainey** for scratches to Saturday's program and entries for Sunday. An Overnight was produce consisting of eight (8) races with fifty-seven (57) runners.

A "Panel" review for Saturday delved into fourteen (14) horses labeled as "Hard Watch" with one of those earning a closer look after it performs at the Test Barn.

FRIDAY11/15/24¹**AMERICANO FILM REVIEW**

Apprentice **MANUAL AMERICANO** was present to review video from Sunday's last race as requested by this Panel. Although he was victorious in this event, we wanted to make him aware that he must do a better job in keeping a straight course down the lane. In the late stages

of this race, he went to the left-handed crop which in turn caused his mount, #7 **HAPPY DOES**, to drift nearly making contact with the runner-up, #5 **HERECOMESGEORGIEBOY** with jockey **FRANK ALVARADO**. At the end of this meeting, it appeared that **AMERICANO** was cognizant of our warning.

Prior to the first race there was still no word from Mr. Amador so it was announced to the Public that **Adrian Castellanos** would be in the irons. **Amador** needs to contact this panel before being eligible to be named on horses going forward.

RACE 2 - DEAD HEAT

When the field of six runners crossed the Finish Line a photo was needed to determine the fifth and sixth horses. Reviewing the picture the two horses, #4-**RICKELLE** and #6-**TRIPLE SLIPPER**, could not be separated so the Placing Judges and Stewards were unanimous in declaring a Dead Heat.
