#### MILLER HEARING

The CHRB filed a complaint against Trainer PETER MILLER for CHRB rules #1902 (Conduct Detrimental to Racing), #1581.1 (Entries) and #1629 (Penalty for Late Declaration) when he entered the horse "Hardmoneymuchachos" in the second race at Santa Anita Park on October 27, 2024. The violation was discovered when the CHRB regulatory veterinarian at San Luis Rey Downs attempted to examine the horse and Mr. Miller's staff advised him that the horse was sick and had left the grounds. Mr. Miller called us seeking a continuance since he received additional paperwork a couple of days ago to amend the complaint. We granted him this continuance and we will reschedule the hearing to a later date.

#### FILM REVIEW

Jockey ARMANDO AGUILAR was in to review his riding crop usage in the second race at Los Alamitos Thoroughbred. Mr. Aguilar used his crop seven times, and had no excuse other than he miscounted. Therefore, the following ruling was issued.

**LATS Ruling #01**

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3 - first offense), Jockey ARMANDO AGUILAR, who rode RASSLER in the second race (Purse \$16,000) at Los Alamitos Race Course on December 15, 2024, is suspended for one (1) day (January 3, 2025), and fined TWO HUNDRED AND FIFTY DOLLARS (\$250.00)\* for one (1) strike over the limit.

Jockey ANTONIO FRESU and Jockeys' Guild Manager Darrell Haire were in to review his riding crop usage in yesterday's sixth race. After reviewing several times, we all agreed that he went over the permitted strikes. Consequently, we issued the following ruling.

**LATS Ruling #06**

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3 - first offense), Jockey ANTONIO FRESU, who rode J B STRIKES BACK in the sixth race (Purse \$200,000) at Santa Anita Race Track on December 26, 2024, is suspended for one (1) day (January 10, 2025), and fined ONE THOUSAND ONE HUNDRED AND SIXTY NINE DOLLARS (\$1,169.00)\* for one (1) strike over the limit.

**SAEZ RULING**

Jockey Guild Manager Darrell Haire came to represent Jockey LUIS SAEZ who possibly violated the riding crop in yesterday's fifth race. **LATS Ruling #07**

Having violated the Horseracing Integrity and Safety Authority Rule #2280 (Use of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 3 - first offense), Jockey LUIS SAEZ, who rode LADY CLAYPOOLE (IRE) in the fifth race (Purse \$61,000) at Santa Anita Park on December 26, 2024, is suspended for one (1) day (January 3, 2025), and fined FIVE HUNDRED DOLLARS (\$500.00)\* for one (1) strike over the limit.

**STEWARDS' INQUIRY/NO CHANGE**

We posted the inquiry sign after the running of the first race (turf) for an incident at the 5 ½ (transition) in which the winner #7 Long Mayshe Reign (R. Gonzalez) shifted inward causing the #2 Avoir (J. Hernandez) and #1 Shop Till You Drop (K. Kimura) to steady. After speaking to the riders involved and reviewing the race, we made no change to the order of finish. In our opinion, the #7 did shift inward, but the incident did not warrant a disqualification.

**STEWARDS' INQUIRY/OBJECTION/DISQUALIFICATION**

After the running of the third race, we posted the inquiry sign to look at an incident at the ¼ pole(turf) involving the fourth-place horse #4 Carole Lombard (A. Ayuso) and the sixth-place horse #6 Highlands (T. Baze). The jockey of the #6 also lodged an objection against the #4 for the same incident. After speaking to the patrol judges and the riders involved, we unanimously voted to disqualify the #4 and place him behind the #6. In our opinion the #4 crossed over the #6 causing him to check losing all momentum.

Jockey RICARDO GONZALEZ was in to review yesterday's first race in which he crossed over at the 6 furlongs turf transition, causing the inside horses to steady. Mr. Gonzalez stated that he did cross over a little too quickly, but he did not go all the way inward and that he stopped just prior to getting to the inside horse. After reviewing the race several times, we felt the incident did not warrant a suspension, but we warned him to be more cautious in the future.

Jockey ARMANDO AYUSO and his agent Rene Amescua were in to review yesterday's third race to look at an incident at the ¼ pole (turf) when he shifted inward putting pressure on the inside horse. Mr. Ayuso said the inside horse contributed, and his horse was a little green; both factors contributed to the incident. We did place part of the blame on his horse; therefore, he was issued a warning.
