Report for the week of June 4, 2025, through June 8, 2025.

WEDNESDAY6/04/25¹**DUTY STEWARD**

Steward Dave Nuesch was present to oversee entries for Saturday night's program. Additionally, he will be drafting the Stewards' minutes for this reporting period.

6/04/25²**THE DRAW**

The racing office compiled sixty-three runners to complete a nine-race program for Saturday.

6/04/25³**CAL-BRED REPORT**

The second race in the book for California bred two-year-old maiden fillies going 300 yards, only received three entries early, but once it was opened-up to all runners, the race was able to be split, going as the seventh and eighth races on the card.

THURSDAY6/05/25¹**SCRATCHES**

Steward Nuesch was present to approve scratches and changes for Saturday evening's card, along with overseeing entries for Sunday's races. Additionally, the entry-panel met this morning to review all of Saturday night's runners, with no panel scratches to report.

6/05/25²**CAL-BRED REPORT**

The first race in the book, for California bred maidens two years old going 300 yards did not receive a single entry and was promptly called off.

6/05/25³**THE DRAW**

The racing office compiled sixty-four runners to complete another nine-race program for Sunday night, which featured the Fred Scane Handicap, going 300 yards.

6/05/25⁴**HEARING DAY**

The Board of Stewards heard four separate complaints filed by the CHRB against trainers Arturo Williams, Jerry Hollendorfer, Jose Flores, and Scott Willoughby, all for allegedly failing to have the required pre-workout exams during the preceding 72 hours of a timed workout. The

first three cases each had just one horse that did not have the required vet-check, and the final trainer testified that his horses did have the exams, but workout restrictions due to rain pushed the works to the following day, thus outside the 72-hour timeframe. The Stewards unanimously agreed that in all four cases an Official Warning would suffice, so those will be issued (in ruling form) over the weekend.

OFFICIAL WARNINGS

Ruling #79

Trainer Arturo Williams is issued an OFFICIAL WARNING for violation of California Horse Racing Board rule #1878(b)(1) (Workouts – Failure to Submit Documentation that his horse Rocky Spirit had been examined prior to a workout on March 23, 2025).

Ruling #80

Trainer Jose A. Flores is issued an OFFICIAL WARNING for violation of California Horse Racing Board rule #1878(b)(1) (Workouts – Failure to Submit Documentation that his horse Dashas Little Pistol had been examined prior to a workout on March 16, 2025).

Ruling #81

Trainer Gerald Hollendorfer is issued an OFFICIAL WARNING for violation of California Horse Racing Board rule #1878(b)(1) (Workouts – Failure to Submit Documentation that his horse Mo Pearls Please had been examined prior to a workout on March 16, 2025).

Ruling #82

Trainer Scott Willoughby is issued an OFFICIAL WARNING for violation of California Horse Racing Board rule #1878(b)(1) (Workouts – Failure to Submit Documentation that his horses had been examined prior to a workout on March 26, 2025.)

CROP RULINGS

Ruling #83

Jockey Francisco J. Ramirez is fined FIVE HUNDRED DOLLARS (\$500.00)* for violation of California Horse Racing Board Rule #1688 (b) (8) (Use of Riding Crop – more than six times during the running of the race) while riding Mis Alacar in the fifth race at Los Alamitos Race Course on June 1, 2025.

Ruling #84

Having violated the Horseracing Integrity And Safety Authority Rule #2280 (Use Of Riding Crop) and pursuant to Horseracing Integrity and Safety Authority Rule #2282 (Riding Crop Violations and Penalties – Class 2-First Offense), Jockey Leonel Camacho-Flores who rode Southern Slang in the Seventh race (Purse \$10,000) at Los Alamitos Race Course on June 1, 2025, is suspended for three (3) days (June 21, 22 and 28, 2025), and fined FIVE HUNDRED DOLLARS (\$500.00)* for five (5) strikes over the limit.

The above two rulings were issued because of two crop violations from last Sunday's races.

Ruling #86

Jockey Francisco J. Ramirez is fined SEVEN HUNDRED FIFTY DOLLARS (\$750.00)* for violation of California Horse Racing Board Rule #1688 (b) (8) (Use of Riding Crop – more than six times during the running of the race) while riding Borntostaythirsty in the third race at Los Alamitos Race Course on June 7, 2025.

The above two rulings were issued as a result of two crop violations on last night's card.
