Ruling #254

JOCKEY IRVING LARA, IS SUSPENDED FOR THREE (3) RACING DAYS (NOVEMBER 14TH, 15TH, AND 20TH, 2020) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (b)(7) (USE OF RIDING CROP-MORE THAN TWO TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FOURTH OFFENSE WITHIN THE PAST 60 DAYS) DURING THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON NOVEMBER 6, 2020.

Ruling #255

OWNER JOSE TORRES IS SUSPENDED FOR FIFTEEN DAYS (NOVEMBER 12 THROUGH NOVEMBER 26, 2020) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1902.5 (ANIMAL WELFARE-UNSANITARY STALL CONDITIONS). DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF JOSE TORRES ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPENDED OR FINE), JOSE TORRES IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Ruling #256

TRAINER ADAN FARIAS, HAVING COMPLIED WITH THE TERMS OF A STIPULATED AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD, IS RESTORED TO GOOD STANDING. ADAN FARIAS IS PLACED ON PROBATION FOR A PERIOD OF ONE YEAR FROM THE DATE OF THIS RULING AND MUST NOT HAVE ANY CLASS I, II, OR III MEDICATION VIOLATIONS DURING THAT TIME.

ADDITIONALLY, ADAN FARIAS HAS APPEARED AND COMPLIED WITH THE PROVISIONS OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY). RULING #LAQL258, ISSUED AT LOS ALAMITOS RACE COURSE ON DECEMBER 17, 2011, IS SET ASIDE.
