California Horse Racing Board Investigator Hunter Bartholomew, Licensee Herrera and all Stewards were on the Teams meeting.

**RULING #50**

After an informal hearing conducted via Microsoft Team on Thursday, January 21, 2021 regarding Case #20SW0029, Trainer Harold Herrera, trainer of record of the horse MAN OF MINE who raced in the first race on Saturday, December 12, 2020 is fined the sum of FIVE HUNDRED DOLLARS (\$500.00)\* for violation of California Horse Racing Board Rules #1843 (a), (b), and (d) (Medication, Drugs and Other Substances); California Horse Racing Board Rule #1843.1 (a) (Prohibited Drug Substances) and California Horse Racing Board Rule #1887 (a) (Trainer to Ensure the Conditions of Horse). Sample #CE30810 was obtained and submitted to the UC Davis Maddy Laboratory, official testing laboratory of the California Horse Racing Board for testing, which showed the presence of Phenylbutazone at the level of 480 ng/mL, which is in excess of the allowable limit threshold of zero tolerance. This is considered a Class 4, Penalty C violation.
