**WEDNESDAY**01/27/21<sup>1</sup>**DARK DAY DUTY**

01/27/21<sup>2</sup>**POST TIME CHANGE REQUEST**

Watch and Wager General Manager Chris Schick requested a Post Time change for Saturday, January 30, 2021 from 4:30 PM to 5:35 PM. California Horse Racing Board Executive Director Scott Chaney, granted this request.

01/27/21<sup>3</sup>**ENTRY DAY**

The race office was open today conducting a double draw for both Saturday, January 30, 2021 and Sunday, January 31, 2021. One hundred ninety-eight (198) horses were entered with one hundred ninety-two (192) drawing in. There is an eleven (11) race card scheduled for Saturday with a Post Time of 5:35 PM and a twelve (12) race card scheduled for Sunday with a Post Time of 4:55 PM.

**THURSDAY**01/28/21<sup>1</sup>**CHANGES**

The Stewards' office was open to take changes for Saturday, January 30, 2021. There were several driver changes and two (2) scratches and four (4) claiming price corrections.

**FRIDAY**01/29/21<sup>1</sup>**CHANGES**

The Stewards' office was open to take changes for Sunday, January 31, 2021. There were several driver changes and no scratches.

**SATURDAY**01/30/21<sup>1</sup>**QUALIFYING DRAW**

Entries were taken this morning for qualifiers to be held prior to the regularly scheduled races on Sunday, January 31, 2021. One (1) race was drawn with a Post Time of 4:20 PM.

01/30/21<sup>2</sup>**PROGRAM CHANGES**

There were no program changes.

01/30/21<sup>3</sup>**RACE DAY**

Eleven (11) races were scheduled tonight over a track rated "Fast" with scheduled Post Time of 5:35 PM.

01/30/21<sup>4</sup>**5<sup>th</sup> RACE WHIPPING VIOLATION**

Driver Doug Chappell, #6 MARYS PRETTY GIRL, was informed that he was being fined one hundred dollars (\$100.00) for violation of the California Horse Racing Board Whipping Rule – second violation in 60 days. Mr. Chappell requested to see the film of the race in question and was invited to the Stewards office at 3:30 PM, Sunday, January 31, 2021.

01/30/21<sup>5</sup>**7<sup>TH</sup> RACE STEWARDS' LIST**

#5 SHEWENTHATAWAY – Trainer Bob Johnson, was put on the Stewards' List for repeated breaks and must re-qualify.

01/30/21<sup>6</sup>**10<sup>TH</sup> RACE FINE ISSUED**

Driver Gerald Longo, who drove #6 TWOMICKEYTRIP crossed over sharply approaching the quarter pole causing interference to #3 WESTERN DEVIL. Mr. Longo was fined the sum of one hundred dollars (\$100.00) in violation of the California Horse Racing Board Rule #1721 (c). No placing was deemed necessary because #3 WESTERN DEVIL finished ahead of #6 TWOMICKEYTRIP in the official order of finish.

Driver Doug Chappell appeared in the Stewards' Office at his request to view the film from his whipping violation from the previous evening. Following the viewing and a discussion with the Stewards, Mr. Chappell understood and accepted his fine.

01/31/21<sup>2</sup>**RULING #51**

Driver Doug Chappell, who drove #6 MARYS PRETTY GIRL in the 5<sup>th</sup> race on Saturday, January 30, 2021 is hereby fined the sum of ONE HUNDRED DOLLARS (\$100.00)\* for violation of California Horse Racing Board Whipping rule #1734 (b)- (whipping shall be restricted to elbow and wrist action only). Second offense in 60 days.

**RULING #52**

Driver Gerald Longo, who drove #6 TWOMICKEYTRIP in the 10<sup>th</sup> race at Cal Expo on Saturday, January 30, 2021 is hereby fined the sum of ONE HUNDRED DOLLARS (\$100.00)\* for violation of California Horse Racing Board Rule #1721 (c) (cross sharply in front of a horse or cross over in front of a field of horses in a reckless manner, endangering other drivers or horses). While driving #6 TWOMICKEYTRIP, Mr. Longo did cross over sharply approaching the quarter pole interfering with #3 WESTERN DEVIL. No placing was deemed necessary because #3 WESTERN DEVIL finished ahead of #6 TWOMICKEYTRIP.

**3<sup>RD</sup> RACE INQUIRY**

The Inquiry sign was caused to be illuminated after the running of the third race by the Stewards to look at two separate incidents regarding breaking horses in the second and third quarter miles. As a result, #7 LIVINONADRENELINE driven by Kevin Anderson was observed to have went inside at least three (3) consecutive pylons approaching the ½ mile pole. According to the Watch and Wager House Rules, a horse racing without interference going inside three (3) or more pylons shall be disqualified and placed last. #7 LIVINONADRENELINE finished 7<sup>th</sup> and was placed 8<sup>th</sup>.

**9<sup>TH</sup> RACE PLACING**

#8 KISS ON THE LIPS driven by Luke Plano was observed to have gone inside one (1) pylon at the top of the stretch, gaining an unfair advantage on his rivals. According to the Watch and Wager House Rules, a horse racing without interference going inside one (1) or more pylons in order to pass another competitor shall be disqualified. #8 KISS ON THE LIPS finished 5<sup>th</sup> and was placed 8<sup>th</sup>.
