In the Matter of: Driver Nick Roland:

Driver Nick Roland, who drove #3 WILD AGAIN in the 2nd race at Cal Expo on Sunday, March 28, 2021 is fined the sum of ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1530 (Cases not Covered by Rules and Regulations – Driving with foot out of stirrup/urging by contact). Second offense in 60 days.

RULING #73

In the Matter of: Driver-Trainer Anthony Succarotte:

After an informal hearing conducted in the Stewards' Office at Cal Expo on Friday, April 2, 2021 concerning California Horse Racing Board complaint #21SW0011, Driver Anthony Succarotte is hereby fined the sum of ONE HUNDRED DOLLARS (\$100.00) and suspended from driving only until he tests clean for Marijuana Metabolites.

Mr. Succarotte is in violation of California Horse Racing Board Rule #1874 (Disorderly conduct); California Horse Racing Board Rule #1500.1 (b) (2) (A) (Random Drug Testing – Marijuana Metabolites); California Horse Racing Board Rule #1489 (a) (8) (Grounds for denial or refusal of license); California Horse Racing Board Rule #1900 (Grounds for suspension or revocation).

In the third (3rd) race a field of five (5) four (4) year old fillies contested the California Sire Stakes for a purse of seven thousand dollars (\$7,000).

In the seventh (7th) race a field of seven (7) three (3) year old colts and geldings contested the California Sire Stakes for a purse of fifteen thousand dollars (\$15,000).

The Inquiry sign was caused to be illuminated after the running of the 10th race due to an incident nearing the top of the stretch. #7 STREET PARADE driven by James Lackey, while sitting on the inside, appeared to be very close to the pylons. After viewing the film, the Stewards unanimously agreed that while #7 STREET PARADE, did go inside one pylon just past the three-quarter pole, he did not gain an unfair advantage. Thus, he complied with Watch and Wager's Pylon rules and therefore did not warrant to be placed. The Inquiry sign was then removed.
