Steward Jauregui was once again present to supervise entries for Sunday, June 6th and scratches for Saturday, June 5, 2021.

FRIDAY6/4/21¹**OBJECTION- NO CHANGE- 5TH RACE (TURF)**

The Stewards posted the objection sign following the 5th race at the request of Apprentice Jockey Jessica Pyfer, who finished fourth on #5 SABINOS PRIDE. Ms. Pyfer lodged a claim of foul against #4 LUCKY PERIDOT (Abel Cedillo) who finished second, alleging interference inside the 1/8th marker. After considering the patrol judge's report, interviewing the riders involved and reviewing the video, we decided unanimously to make the original order of finish official. The video shows a tiring #5 SABINOS PRIDE steady briefly as #4 LUCKY PERIDOT passes and drifts in slightly. We determined #5 was inconvenienced, but the incident did not cost her the opportunity of a better placing.
